Annually only one award would be given. Award committee will select **ONLY ONE** eligible candidate out of the total number of nominations.

The decision of the award committee is final.

Criteria's for the member of good standing:

- He should be the life member of the society.
- Should have attended min 3 annual conferences as a life member in the past 5 years. b.
- No financial default be there on any form either in ISPPD or in any other society/ association.
- Should not have violated any rules of the professional registered body. d.
- No civil or criminal litigation pending.
- Should have actively participated in the association activities. f.
- g. Any member who assumes the post should execute the responsibilities.
- h. Any breach in the continuity will not considered as a member of good standing
- i. Any member who remains dormant from the association or the profession is not a good member.



- *After becoming a student member or life member of ISPPD only to be considered (Publication done during UG, Internship and working as junior lecturer will not be considered).
 - *Article cited index Scopus h index and i10 index to be submitted with your publication list
- 2. Books:
- *Author of Text Book concerned to our speciality Chapter/Contribution in book
- *Peer reviewed book
- *Renounced publisher
- *Book should have revisions and new editions.
- *Books should have relevant contents page and references.
- 3. Poster:

Presented as first author alone need to be sent for the award.

- 4. National level or regional level paper/poster presentations or publications should be limited to 3 only.
- 5. Abstracts published in journals: not be submitted as publications.
- 6. Ahead of print and manuscript accepted for publication: not to be submitted.
- 7. Online first: can be submitted.
- 8. Age Limit: 35 years (Date of Birth: <u>Born on or after 01/07/1981</u>). Submit photocopy of any one of these documents: Passport/ PAN Card/ Adhar Card/ Driving License/ 10th School Leaving Certificate.
- 9. Submission SHOULD REACH ON OR BEFORE: 15th July 2016 to ISPPD Head Office address:
