He thanked and congratulated all the Past Presidents, Office bearers, Present Office bearers for this milestone achievement. He credited the achievement to the team for timely and effectively approaching various officials and the effort of all the members.

• AHAR, HRA [WI] and NRAI jointly presented a memorandum to the Additional Municipal Commissioner Shri Sanjay Deshmukh regarding simplification of rules / regulations.

# 'Timely action' ......

Smoking area will not be the part of food serving area etc. AHAR expects a favourable response from the authorities in the coming days and get much relief under 'Ease of Doing Business campaign by the Union Govt.'. AHAR will represent to the State Government for a suitable order for repealing of 394 MCGM license..

- A collective effort proved to be the only way to get justice once again .After the announcement of the Housing Minister's Amendment to The Maharashtra Rent Control Act the matter had been withdrawn six months ago due to protest and opposition by AHAR jointly Teaming with FAM, RTWA, Tenants Association. A meeting of the Joint Action Committee held on 18th January 2016 has decided to oppose the amendment and send a resolution to CM to withdraw the same permanently. The joint action committee had also approached MLAs of various political parties for their support against this draconian amendment. The Joint Action Committee is happy to announce that due their strong opposition expressed by the Joint Action Committee, Tenants and the General Public the Honourable Chief Minister Shri Devendra Fadnavis has announced that the Rent Control Act will not be amended. It is again a victory for the joint efforts of all Associations. However, the committee will pursue the case further till the tenants get their right of ownership.
- A representation was submitted to the State Excise Minister and the Principal Secretary to reduce the FL-III License fees to save the Hospitality Industry. A team of AHAR representatives scheduled to meet with the concerned Minister to pursue various demands.
- AHAR President advised the members to apply for the piped gas connection from Mahanagar Gas Limited. The Team from AHAR had two meeting with the General Manager, Commercial of MGL for addressing the grievances of the members. President further said that the application form for piped Gas from Mahanagar Gas is available at AHAR office. He said the bottleneck of providing service of piped gas connection due to MCGM provisions / conditions were reduced to 4 in place of 14, which also reduced the

digging charges.

### **Speech by Advisors**

### Shri Santosh R Shetty

He briefed how he was able to get the MGL Piped Gas Connection after fighting for almost 3 months. He also thanked Shri Narayana M Alva for the

support in resolving the issue. In the Amendment of Rent Control Act we should go for temporary relief, but strive to get permanent relief and see that the draconian amendment to the Rent Control Act is scrapped. We must get information of RTI activists through RTI application and classify the malafide motives of the activists. We should complain against them with papers gathered to the Police Commissioner, who can initiate action against such activists. We must learn to respect our leaders and any genuine complaints, the hotelier should personally bring the complaints, as he knows the facts better. We must approach the FDA commissioner and pursue him to write to the Government for scrapping 394 License in lieu of the FSSAI. The present team is doing excellent work and the results are in front of us. We need to support the team wholeheartedly.

### Shri Narayana M Alva

President has made presentation of the happenings in a very comprehensive way. In RTI matters we must convince the authorities not to divulge any personal information. Due to our proper coordination and follow up MGL has come to our door and we should take benefit from them.



# **Allow FDI in multi-brand retail** for food grown and processed in India: Harsimrat Kaur Badal

Mumbai: In her inaugural address at the seminar on opportunities



in the Food Processing Sector, Smt. Harsimrat Kaur Badal. Honb'ble Union Minister for Food Processing Industries, said the food processing industry was going to explode in the next few years. The seminar was organized by CII in partnership with the Ministry of Food Processing Industries, Government of India as part of the ongoing Make in India week in Mumbai. The Minister released the report on 'Make in

India – Review of Food processing opportunities in India' at the Seminar.

She pointed out that India has the largest raw materials base, food production levels have quadrupled, and we are a food secure country and have the potential to become the food factory for the world. Speaking on the issue of FDI she proposed allowing FDI in multi-brand retail of food grown and processed in India to sell to India and the world. Such FDI will by no means shut down the smaller mom and pop shops. In addition, the wastage of food worth Rs 92,000 crore will be reduced. She believes that this will also help to modernize the Indian farmer with newer and efficient farming technologies. She highlighted recent efforts by the government to encourage greater innovations and enable the ease of doing business through cheaper credit, identifying priority sector lending status for foods grown in India and others.

She said India can take its nascent levels of mere 10% in food processing to the next level of 30%. She also encouraged investors and the Industry to look abroad at the large expat population and the huge opportunities that lie with traditional foods both abroad as well as here. According to her, the 42 proposed food parks will significantly impact food processing levels.

The food processing sector in India contributes as much as 11 per cent and 9 per cent of GDP in Agriculture and Manufacturing sector respectively. It is one of the largest industries in India, ranked fifth in terms of production, consumption, export and expected growth. Also, it is considered having huge potential for elevating agricultural economy, raising farmer's income, generating employment and enhancing forex earnings.

She invited the Industry to come forward and invest with innovative ideas and game changing thoughts to support the larger vision of providing cheap, affordable, healthy and nourishing food to Indians and the world.


