Adarsh B. Shetty President of the Association presided over the meeting. The meeting was attended by a large number of members, dignitaries, representatives of various other organizations and advisors.

The event began with the traditional lighting of lamp by the Advisors Shri. Shivram Shetty, Shri. A.B. Shetty, Shri. Chandrahas K.Shetty, Shri. Sudhakar Hegde, Shri. S.M.Shetty, Shri. Narayana Alva, Shri. Sudhakar Y Shetty, Shri. Sukesh Shetty Honorary General Secretary, Shri. Nitin Shetty, Honorary Treasurer and Shri. Adarsh Shetty, President, AHAR.

The President commenced the meeting as per agenda circulated to the members vide circular dated 20.11.2015.

#### Welcome address:

President Shri. Adarsh B. Shetty extended a hearty welcome to all advisors, senior hoteliers, ex-presidents, office bearers, Managing Committee members, invitees, sponsors, media and well-wishers for attending the meeting.

#### Confirmation of minutes:

The minutes of the 35<sup>th</sup> Annual General Body Meeting held on 16.12.2014 which was circulated earlier under notice dated 20.11.2015 were taken as read with the consent of the house. The confirmation was

#### **Adoption of the Annual Report:**

The 36th Annual Report of the Association circulated earlier under notice dated 20.11.2015 was taken as read with the consent of the house. The house unanimously

#### Adoption of Auditor's Statement of Accounts for Fiscal Year 2014-2015:

Shri. Shashidhar Shetty Hon. Treasurer briefed about the financial position of AHAR during the year in detail and said that due to heavy legal expenses incurred during the period, the association faced a deficit in the expected target for the Corpus Fund. He said the excess expenditure over the income of Rs. 15,99,140/- was due to heavy legal expenses. He said, till date an amount of Rs.31 lakhs was spent on various legal cases. He requested members to step up the membership drive and support AHAR through contributions to the legal fund.

The Annual Statement of Accounts duly audited and the auditors observations circulated earlier under the notice dated 20.11.2015 were taken as read with the consent of the house. The same was duly adopted. The adoption was

#### Appointment of auditors for the year 2015-2016:

It was resolved unanimously to reappoint M/s Y.R. Shetty & Company as the auditors of the association for the year 2015-2016. The appointment was unanimously approved.

#### Discussion for creating the AHAR Legal Fund:

The President Adarsh Shetty briefed that

the Association has to file several legal cases against various government and civic authorities to protect the interests of the hospitality industry. At present we are having BEST, TDLR, Minimum Wages. Service Tax, FSSAI matters in the Bombay High Court and Supreme Court of India, we have to appoint the advocates of high caliber, face value to defend our case to bring the expected results. Due to our financial limitations, in several cases we could not pursue these cases with the best lawvers and had to opt for lesser known legal faces resulting in not getting the expected results. Further the grievances/problems are on rise every year.

Hence it was decided to raise a healthy Legal Fund through donations from the hoteliers/restaurateurs initially to the tune of Rs.5 crore. The Fund will be kept in Term Deposits and the earnings on it will be utilized for meeting all the legal expenses.

We will employ the best available legal brains to defend our cases which are filed after extensive discussion, study, possibilities to protect the interest of the entire hospitality industry without restricting it Mumbai alone. A committee of Advisors, present office bearers, known hoteliers and highest donors will be formed to work out the modalities to raise donations.

He asked the house, whether they agree with his proposal. The entire house unanimously agreed on the same.

The house passed the following resolution unanimously.

It was resolved that an amount of Rs. 5 crore will be raised through contributions from members, well wishers as a Legal Fund. The returns on the Corpus Fund will be used for meeting the legal expenses of the Association in various legal matters to safeguard the interest of the Hospitality Industry. The modalities of using/deploying the fund will be decided by the Committee appointed for the purpose. The resolution was unanimously passed

#### President's address:

In the current year we were able to address many problems of the hospitality industry and also highlight the prevailing scenarios to the general public through the media and the social media network.

I will enumerate the events that occurred through the year:

- **1.** Wide coverage of grievances of the hotel, food & beverage industry was highlighted in the print, electronic and social media. All leading channels and newspapers had interviewed the President and given wide coverage.
- **2.** AHAR sponsored Swatch Bharat Abhiyan in various Zones of the city and suburbs. Our efforts were well appreciated by the public and MCGM officials. AHAR had advised all the hotels & restaurants to keep their premises clean and hygienic throughout the year.
- **3.** AHAR through its powerful delegations stopped the harassment by elements like the OBC Brigade and a personal secretary of leading politician who were harassing and blackmailing restaurateurs were arrested.
- **4.** Met the Labor Minister of the state and convinced him about the harassment by NGOs with the help of police in child labour related issues. These NGOs and cops were allegedly harassing the hoteliers who employ persons above the age of 14 years. The minister has assured that such harassment will be addressed through proper notifications.
- **5.** AHAR along with associations such as FAM, FRWTA united and fought against the proposed amendment to the Rent Act of Maharashtra and got it scrapped. The efforts and support of Ms. Shaina N.C, Shri. Dhanave, State BJP Chief, Shri. Vinesh Mehta, FAM and Shri. Chandrashekhar Prabhu in this matter is well appreciated.

If this amendment was implemented, it would have affected 85% of the hoteliers running their business on rental or pugree system and the heavy hike in rent would have compelled them to shut their business.

- **6.** Through AHARs intervention and meeting with Shri. Sanjay Pandey, former Commissioner of Metrology department stopped sealing piped gas meters of Mahanagar Gas Co Ltd throughout Mumbai. We proved that it is the error on the part of MGL not putting the meter as per the specification of Metrology Department and that hoteliers should not be penalized.-
- **7.** An agitation by RPI to include Maharashtrian dishes in menu of all restaurants in Mumbai & suburbs and taking

extreme steps if their demand were not met was attended by the President Adarsh B. Shetty. Through proper discussion the matter which would have blown out of proportion was nipped in the bud.

- **8.** Met the State Finance minister Shri. Sudhir Mungantiwar and briefed him about the high taxation and other grievances of the restaurants industry. He assured us of considering our suggestions in the ensuing budget.
- **9.** The murder of a senior citizen by an ex employee of a hotel in Santa Cruz was immediately attended and got the killer was arrested. Sent message to all hotel and restaurant members to keep record of the employees like PAN Card, Vote ID or Aadhar Card in record to save ourselves from such unforeseen events.
- **10.** The bold step taken by AHAR in Hotel Mantra, Malad case wherein the police along with anti social elements raided the hotels in spite of following all regularities and began harassing couples. AHARs stand was well supported by the elite citizens and the Police Commissioner was forced to issue a statement admitting the mistake of police officials.

The Bombay High Court has asked the State Government to explain under which rule the Police conducted the raid. The print, electronic and social media has given maximum coverage in the leading channels and news papers to this issue.

- 11. A landmark and historic judgment in the writ petition filed by AHAR in Dance Bar case wherein the Supreme Court of India stayed the implementation of section 33A and advised the State Government to renew the licenses. It paved way for revival of this industry which employs lakhs of people including artists who earn their livelihood.
- **12.** For the first time a President of AHAR was invited and had a participation in chat show by BBC.
- **13.** Filed a petition against illegal food hawking in Bombay High Court citing the violation of Supreme Court banning cooking food. We have made all important department heads as party and served the notice. The Writ Petition is expected to come to board soon.
- **14.** Indian Drug Manufacturing Association has appreciated the logistic support provided by AHAR in their fight against FSSAI Rules and winning a historic case.

They acknowledge the same by felicitating Shri. Adarsh Shetty during their National Convention held in Mumbai

- **15.** AHAR fought against the actions of the MCGM authorities in cancellation of the license of Laxmi Hotel, Dadar due to the powerful lobby of a developer and had the same revoked.
- **16.** Handled efficiently the aftermath of City Kinara Hotel fire tragedy, met the Municipal Commissioner and submitted our grievances and misuse of power by the MCGM authorities. This has resulted in MCGM proposed to reduce the total licenses, NOC etc to 15 from 42 and also easing the licensing conditions.
- **17.** The Minister for Food Processing Industries has invited AHAR for meeting to discuss the FSSAI related matters. On our request they have agreed to meet our delegations separately.
- **18.** We had appointed a full time PR Agency I-Deators Communication Pvt Limited for a proper media, electronic and social media coordination and highlight the grievances, harassments of the hotels and restaurants throughout the year.
- **19.** Got our in-house newsletter and magazine duly registered with the RNI and thereby getting the concessional postal charges.
- **20.** Due to efforts of AHAR on the advice of the Municipal Commissioner, the Mumbai Fire Brigade has give clear guidelines in fire safety and simplified the norms for applying for Fire NOC.
- **21.** Supreme Court directed the State Government to renew all the licenses of performance bar applied for.
- **22.** Presented in detail our grievances, problems faced and suggestions on various rules of MCGM jointly with HRAWI,NHA to the Municipal Commissioner, who assured to address the same. Perhaps it is the first time that such a comprehensive memorandum for simplification of archaic, duplication, avoidable rules of the Municipal Commissioner.
- **23.** Due to efforts of AHAR, MCGM has withdrawn the demand of NOC from Assessor and Collector in property tax and undertaking in fire safety for renewal of license.

He said we should work together with understanding and not with criticism. The young generation of hoteliers should be brought to AHAR fold.

He said he looks forward for the complete and whole hearted support and co-operation of members, so that we can finish the planned agenda in total. I call upon members to make this association a strong one. I look forward to a reduction in problems, grievances faced by the industry and have a peaceful business environment to earn our livelihood without any fear or interference.

He also said that his agenda for the coming year for restaurant and hoteliers will be:

- **1.** Install CCTV at all hotel / restaurant premises, which will save you from many hardships.
- **2.** Make all establishment fire compliant and make regular auditing of fire equipments, electrical installations.
- 3. Keep all premises neat and clean.
- **4.** Use water judiciously and save water.
- **5.** Not to afraid and bow under pressure to any authorities. Fight against it, AHAR is always with you.

With this he concluded his Presidential Speech and wished all the members and their family a very happy, healthy and prosperous New Year 2016.

We present here below the gist of important activities of the Association and the major events during the year.

#### 36th Annual General Body Meeting.

#### Office Bearers meetings

With a view to address the issues concerning the hotel industry, 34 Office bearers meetings were convened during the year. As a result, timely action was initiated in most of the issues for the benefit of members.

#### **Financial Status**

In the year under review the association has had an excess of expenditure over income of Rs.3,35,717.32 compared to last years Rs.15,99,140.00. The reason for the same being the heavy legal expenditure and expenditure on in house news letter and magazines. The association had to challenge a number of decisions of the state and central government in the interest of the hospitality industry.

#### Till date the following legal expenses were incurred.

Challenging the service tax on air-conditioned hotels in Mumbai High Court & SLP in Supreme Court Rs. 23,16,510/-AHAR had filed a Writ for early hearing of the matter. Supreme Court rejected the same and said that matter will come in routine.

Appeal in Appellate Tribunal against levy of cross subsidy Rs.11,63,684/-

Appeal in appellate Tribunal for Electricity against Regulatory Asset Charges Rs.5,88,173/-

AHAR supporting WP by Shri Guruprasad Shetty in Supreme Court against BEST appeal not allowing TATA to supply to Mumbai City which was dismissed –Rs.3,14,205/-

WP against excise fee hike of 50% in Bombay High Court Rs.1,00,000/-

sign board legal opinions -Rs.30,000/-

WP in illegal food hawkers in bombay high Court -Rs.3,00,000/-

Challenging the imposition of T.D.L.R by BEST in Appellate Board, New Delhi Rs.100,000/-

Fighting against imposition of certain clauses detrimental to the interest of the hospitality industry in the newly Introduced FSSAI Act in the Hon'ble Bombay High Court Rs. 6,15,000/-. We have lost the case and filed SLP in Supreme Court , which is yet to come to board.

Challenging the exorbitant hike in minimum wages notification in the Hon'ble Nagpur High Court Rs. 17,64,870/-. The court has directed to make 70% of revised minimum wages till final order.

Membership fee and sponsorship amount received by the association is the only source of income and the same are not be enough to meet the huge expenses incurred due to the various petitions. We are compelled to depend on the own funds which may adversely affect the financial status of the Association in future. There is an immediate need to mobilize a strong fund.

#### Relation with various government and semi government bodies.

The Association was in constant touch with various departments of MCGM. Police, Excise, Labour, etc. and maintained a cordial relationship with them.

#### Performance of the various committees

#### [1] Promotion committee

The promotion committee led by Shri Sunil Patil alongwith Shri Mahesh Shetty and Shri Vijay Shetty was instrumental in negotiating with manufacturers and vendors, companies for providing their products at a discount to the members of AHAR. Many newly launched liquor brands are registered with AHAR. Due to their efforts every monthly meeting was supported many vendors through Stall participation.

#### [2] Excise Committee

The excise committee under the chairmanship of Shri Vijaykumar Shetty [Mumbai Suburbs] and Shri Mohan Shetty [Mumbai City] resolved a number of issues pertaining to the excise matters. They were vigorously pursuing the simplification of licensing conditions. Their regular coordination with authorities has resulted in minimizing the grievances.

#### [3] M.C.G.M Committee

The M.C.G.M committee under the leadership of Shri Niranjan Shetty has attended to all the issues pertaining to MCGM and was able to resolve most of the above issues promptly. The proper coordination with executive medical officer of health and other divisions of MCGM benefited the members immensely. A number of meetings were convened with various asst municipal commissioners of various Wards along with concerned department heads a number of grievances, matters discussed and got resolved. Their regular contact and interaction with various authorities had resulted in solving a number of grievances. The arranging of meetings with the Governor, Hon'ble Chief Minister, Hon'ble Finance Minister, Hon'ble Labour Minister and Municipal Commissioner with Grievances of the industry was initiated by Shri Niranjan Shetty and has paid the rich results and positive developments.

#### [4] Police Committee

The police subcommittee under the leadership of Shri Shailendra Shetty [City] and Dr.Satish Shetty [Suburbs] did their best to minimize the grievances and problems of our members. The committee was instrumental in simplifying License conditions like

Inclusion of managers name in the PPEL, renewing of pending PPEL due to minor charges, and also managed to restrain the department from the unnecessary harassment during business hours. Meeting with the Joint Commissioner of Police, Law & Order and Additional Police Commissioner has resulted in reduction of harassment by police in child labour matters.

#### [5] Legal Committee

Legal committee under the leadership of Shri Shrinivas Shetty is attending to the various pending legal issues. They are also instrumental in drafting many suggestions, recommendations to the municipal commissioner, home department and others. He has taken a lead in fight against the amendment to the rent act by the government and succeeded in stalling the same.

#### [6] Performance Bar Committee

Headed by Shri Bharat Thakur the committee has brought a landmark judgment of staying 33A by Mumbai Police and the

Supreme Court directing the state government to renew the pending license. The final verdict has paved way for restarting the performance Bar and thereby giving employment opportunities to lakhs of artist, employees throughout the State. We appreciate the unity of performance bar hoteliers in pooling their resources in this legal battle, which was fought since last fifteen years. He is ably supported by Shri Shashi Shetty, Shri Uday Shetty and Shri Yeshwant Shetty and his team.

#### [7] FSSAI

FSSAI committee is headed by Shri Pramod Nayak. Ahar was coordinating with FSSAI authorities in Mumbai and has solved many grievances of the members. He has also attended convention and seminars in Delhi convened by FSSAI. He along with Shri Arvind shetty are continuously corresponding with FSSAI regarding the impossible conditions imposed on restaurants and simplification of the same. The committee also conducted training camp for online registration/renewal of FSSAI licences in Ahars office and trained our members in the process.

#### [8] Publication Committee

Thanks to the dedicated and relentless efforts exerted by the Publications Committee, AHAR Hospitality and AHAR Connect are now have emerged as authoritative publications for the entire food, beverage and hospitality industry of Mumbai and elsewhere. AHAR Hospitality and AHAR Connect now reach the desks of decision makers in the Municipal Corporation of Greater Mumbai, Food Safety and Standards Authority of India and various ministries and departments of the Maharashtra government and the Central government. These publications are also referred by students aspiring for careers in the F&B and hospitality industries while serving as ready reckoners for those desirous of investing in the trade. The Publications Committee's efforts have helped news relevant to the industry proliferate to all stakeholders within short time. In the on-line platform such as www.ahar.in and the social media connect such as facebook & twitter are gaining momentum in spreading the news and views of various events activities, notices, circulations and the information pertains to the industry is reaching at lightning fast. By occupying a commendable position in the on-line space AHAR has a global visibility.

#### [9] Office Administration Committee

The committee was headed by Shri Santosh R Shetty assisted by Shri Vishwapal Shetty was closely monitoring the administrative functions of the office. They have introduced many innovative measures for smooth function of the office.

#### [10] Public Relation & Media Committee

Under the chairmanship of Shri Adarsh Shetty has highlighted the various important issues like moral Policing by police personals, performance Bar matters, and other issues in print media and TV media to the maximum level.

A number of leading English and vernacular dailies highlighted the grievances affecting the hotel industry.

#### [11] Membership Drive Committee

The Membership Drive committee under the chairmanship of Shri Adarsh Shetty has collected an amount of Rs. Twenty eight lakhs till date as renewal, enrollment of new membership etc.

#### [12] Labour Welfare Committee

The labour welfare committee under the chairmanship of Shri Shivaji Shetty ably supported by Shri Sunil Patil has conducted Free medical checkup and eye check up camps throughout the city and suburbs. More than five thousand hotel employees got benefit of these camps. The entire expenses of the free medical checkup camps with doctors of various faculties were borne by the members of respective Zones. We are also supporting Prabhodini Nagri Seva in its aids awareness drive and National Association for Blind who are supporting us in conducting the free eye check up camps.

#### [13] Hawkers Action Committee

The Committee under the chairmanship of Shri K.K.Mahale and ably supported by Shri Samith Arasa has filed a writ petition in Bombay High Court against the illegal food hawkers making almost all various government authorities as the party. The petition is coming up for hearing very soon. They have also filed intervention appeal in the case of illegal food hawkers with Kelavani Mandal. The committee is trying through all sources to include the Associations representatives in the proposed town and ward vending Committee of MCGM, which is now accepted by the government. In a landmark judgment Bombay high court given the verdict that illegal food hawkers are not covered by definition of the Street Vendor Act and has directed the MCGM to take action for removal to safe guard health of Citizens. It is decided to approach the Bombay High Court for implementation of order by MCGM.

#### [14] Copy Right Committee

This committee is lead by Shri Vilas Jhaveri. The issues of IPRS,PPL and ISRA were handled by the team. The committee through the support of HRA[WI] and the legal experts has prepared the draft reply for any of the queries or demands by these agencies, which was readily provided to the members.

#### [15] Other Associations of Maharashtra

Shri Sunil Patil is the chairman of all Hotel Associations of Maharashtra committee. He is ably supported by Shri Vihwapal Shetty .They did an excellent job in coordinating with all the Hotel Associations of Maharashtra and bringing them in maximum numbers in the meeting of all Maharashtra Hotel associations held in Mumbai in a single platform. The committee also keeping a close coordination with HRA[WI], FAM, FRTWA, NRAI and others and have in regular interaction with associations throughout the state of maharashtra.

#### Coordinator

Shri Sudhakar T Shetty was the coordinator for all the sub committees. He did a good job of coordinating with the entire sub committees and getting feed backs, presenting them in meetings etc.

#### Other Events during the year

#### • Mumbai Port Trust Tenancy Issues

BPT is issuing notices and eviction notices to the tenants and sub tenants. This is affecting a number of restaurants who are the tenants or sub tenants of MBPT. The MBPT is using silent and systematic method of sending notices. It is high time all BPT tenants unite and fight against these notices. AHAR is uniting all such hotelier tenants. It is also proposed to have a silent morcha and bring the matter into limelight. We will provide the TV and media coverage. We should approach and involve all political parties for their support in this fight of survival.

#### • FL-III license not hiked for the current year

Due to efforts and continuous follow up by AHAR, The Government of Maharashtra has not hiked the FL-III License fee for the current year. The FL-III License fees for Mumbai is Rs.6,00,000/-. It is a great achievement and relief to the permit room hoteliers.

#### • AHAR Presented Cheque of Rs. 20 lakhs to Chief Minister Drought Relief Fund

A delegation of AHAR presented chque as a donation of Rs. 20 lakhs to CM Drought Relief Fund. It also submitted and discussed repealing of 394 license of MCGM and waiving eight time fees for transfer of FL-III License.

#### • Submission against Proposed hike in Electricity Tariff by REST

We had submitted our objection for hiking the electricity tariff by BEST and also submitted for discontinuing of TDLR by BEST. Our delegates also met COO of Tata Power regarding multiyear tariff and put forth our suggestions, objections. We had also submitted letter In this regard to CM, MERC and energy minister.

#### • Meeting with Excise Commissioner

Our delegation met the Excise Commissioner Smt V.Radha and presented three main demands:

- 1 Repealing of the requirement of Permit in Permit Room.
- 3. Removal of eight times license fee for FL-III license transfer
- 4. Exemption of FL-III License fees during redevelopment period (Safe Custody). Also met the Vigilance, Flying Squad, superintendant of the city and suburb, who assured us of attending the complaints of selling of illegal liquor within 48 Hours. The Excise Commissioner was very positive and assured attending the grievances of permit room hoteliers in a transparent and practical way.

#### • Meeting with Ms.Heather Roberts, Manager, Sydney TAFE on 18.3.2016 at office

An Australian Government, New south Wales sponsored program on food safety and hygiene lead by Ms. Heather Roberts met AHAR office bearers and sought our support in the program. We had assured our support.

• A delegation of AHAR met the Joint. Commissioner, FDA and discussed about the difficulty in online registration, impersonation etc. He agreed to conduct awareness seminars and also train personnel from AHAR in online registration/ renewal process. On our request, he provided list of all Assistant Commissioners (FDA)their contact numbers. It is available at the AHAR office. They have already trained few of our members, who will in turn train others so that the online registration/ renewal of FSSAI licenses will be smooth.

#### • Meeting with FSSAI CEO

Team AHAR was invited as a stake holder in the recent decenary celebrations of FSSAI and seminars/interaction with central ministers, CEO FSSAI and others. The meeting was very positive and the CEO FSSAI assured of inviting AHAR to its important meeting and will accept the pragmatic suggestions offered by it in the larger interest of the hospitality industry.

#### • Electricity matters

We had submitted our suggestions/objections in BEST proposed MYT to MERC and Shri. Guruprasad Shetty represented AHAR in the hearing held on 24th and 25th of May 2016 and presented his arguments. Shri. Kamlakar Shenoy also argued as the activist. Due to efforts of AHAR the TDLR is removed in r bills of residential consumers of BEST and will be removed in the bills of commercial establishments soon. The effort of AHAR has resulted in benefit to lakhs of hoteliers, shopowners, traders and also the residential consumers.

#### • Meeting with MWWMA

We had a joint meeting with the Maharashtra Wholesale Wine merchants Association on at our office regarding the issue of reduction in cash discount by the distributors. The MWWMA has put forward that their margin by the distributors has also reduced. It is decided that it is high time that we should fight against this unilateral decision of the distributors/liquor manufacturing companies. Due to the joint efforts of AHAR and MWWMA, the CD was restored back. The matter od serving liquor by wine shops are discussed and MWWMA assured stopping the same.

#### • E-coli in Ice used in restaurants

Recently FSSAI officials and MCGM officials has raided several restaurants testing the ice used by them for consumption and found high concentrations of E-Coli which is detrimental to human health. FSSAI has requested AHAR to instruct their members to use only the ice which are approved by FSSAI. We suggest using FSSAI approved ice cubes, Our timely advice to members has saved them from notices, harassments by the authorities.

#### **APMC Strike & supply of Vegetables & Fruits**

A delegation of AHAR met Shri, Mohammed Arif registrar of Division and Shri. Sunil co-operative societies, Mumbai Porwal, Additional Chief Secretary, Planning & Others on to discuss the supply of vegetables and fruits to hotels and restaurants due to strike in APMC. The additional chief Secretary assured uninterrupted supply of vegetables/fruits through various MCGM markets and also from whole sellers who, procure from peasants and supply to us. They have mailed entire list of suppliers, which has been uploaded immediately on our website and members were Informed through bulk SMS and emails. Due to AHARs effort, the members did not face any shortage of supply of fruits/vegetables.

#### Service tax on parcels

A delegation of AHAR met the Chief Commissioner, service tax regarding clarification of service tax on parcels (take-away food). On his advice we had submitted our suggestions/objections to the service tax on parcels to the board of service

tax, Delhi and others for clarification. PMOs office has forwarded our letter to concerned department for clarification.

#### • Public Interest Litigation (PIL)

A PIL has been filed by Shri Sumeer Sabharwal against State of Maharashtra [police raids on hotels] and moral policing by Mumbai Police. AHAR has also intervened in this matter to safeguard the interest of residential hotels. The matter is deferred and yet to listed in the board.

#### • Meeting with Municipal Commissioner

A delegation of AHAR met the Municipal Commissioner regarding of demolition of duly permitted open space of restaurants. We argued why only hotels/restaurants were targeted, as open space is used after paying the required fees and getting the permission. The MC assured redressing the same.

#### • The Performance Bar case

In Supreme Court challenging the impossible conditions laid by the state government will be coming for final hearing, in the month November 2016.

#### For Information of Members (Important)

- 1. Minimum thickness of plastic carry bags should be of 50 Microns. Environment Ministry has announced that the minimum thickness of plastic carry bags is 50 microns. It should be strictly followed. Any lapse will result in heavy fines. The members are advised to note the same.
- 2. To use the ice for consumption only from the FSSAI approved vendors/manufacturers. Due to finding of E- Coli in ice used found in various raids by MCGM which is detrimental to the health of the consumers, members are advised to purchase the ice for consumption only through the vendors/manufacturers who are duly registered with FSSAI.
- **3.** It is advised to use the portable swiping card machine for customers who opt to pay through credit/debit cards.

#### Relationship with media

AHAR had maintained a very cordial relationship with press and electronic media. We had appointed I-Deators communications as per PR Agency. They did an excellent work in coverage's of important news, grievances etc. in press, electronic and social media. Times of India, DNA, Hindustan Times, Midday, Mumbai Mirror, Indian Express, Forever News, Free Press Journal, Lokmat, Economic Times, Karnataka Malla, Udayavani from Press and ABP, TV9, Zee, Star, IBN from electronic media had given the continuous coverage of issues pertaining to industry. We sincerely acknowledge their contribution to our growth.

#### Relationship with sister concerns / affiliates

AHAR has kept very cordial relationship with other associations and affiliates. In the current year AHAR ushered a new beginning by interacting with HRA [WI] and forming a coordination committee. AHAR aim is to raise one voice against the injustice meted to the hospitality industry through united front in a single platform. Kept cordial relations with all affiliated hotel associations of the state.

#### **Charity Support**

We are supporting Nagri Seva Prabhodini an NGO in its efforts of aids awareness and with National Association for the Blind in its blindness eradication program. We also support City Space [NAGAR] in their efforts of save mumbai campaign.

We are thankful to various sub committees, authorities, departments of MCGM, Excise, Police and other statutory authorities for solving a number of grievances concerning to the hotel industry.

## Milestone achievments of AHAR during the year

#### Simplification of NOC from Fire Brigade

The effect of Kinara Hotel fire incident was minimized due to timely meeting with the Municipal Commissioner. On our persuasion the MC has directed the Chief Fire Officer to simplify the procedures of issuance of fire NOC. The issuing of Fire NOC procedures were simplified and notification in this is issued by Mumbai Fire Brigade.

Due to our campaign of displaying the board of fire compliance, awareness about fire safety, and advised the memerbrs to adhere to the fire safety norms, the serious matter was resolved and frequent raids on hotels/restaurants were regulated.

#### Police Notification of Cancellation of Police Licenses

- The State Government has issued GR regarding cancellation of Police Licenses to hotels/restaurants. It is due to the effort of AHAR since last ten years. It is great relief to the restaurateurs especially the permit room owners. Hence there is no necessity of renewal of RC or PPEL. The licenses cancelled are:
  - Eating house registration certificate.
  - Place of public entertainment license.[PPEL-A]
  - Place of public entertainment license [PPEL-B-lodging]
  - Swimming pool license.
  - Performance license

#### **Simplification of MCGM Licenses**

Due to the continuous discussion, meeting and follow up with the Municipal Commissioner and other authorities and after convincing the Chief Minister about the outdated licenses leading to duplication and harassment, MCGM made a number of amendments. MCGM has repealed the following licences.

- 1. Madira License. In its place a payment of a fixed amount as fee for serving liquor.
- 2. Grade license in restaurants.

#### The following are introduced

- 1. Provision for renewal of MCGM licenses for 5 years.
- 2. Any dustbin or suitable dust bin in place of metallic trash cans.
- 3. Smoking area will not be included in serving area for area

calculation.

- 4. Medium of cooking, fuel or electricity
- 5. Height of kitchen as per building and proposal departments approved plan. About Rule 394, the Additional Municipal C o m m i s s i o n e r confirmed that the matter will be decided



by the State Government. In case they agree for the same the MCGM has no objection and will implement it. The matter has been discussed and conveyed Chief Minister, who had forwarded our appeal to the concerned departments for inputs and assured its redress the earliest

#### **Amendment to Rent Act by government:**

Bowing to the pressure by various associations of tenants and highlighting the matter In print media and TV by AHAR, The Chief Minister has declared that the Rent Act will not be amended. AHAR and other Associations has decided to fight till the tenancy right is converted into ownership right. We are also fighting against the proposal of MHADA of changing the rules in DC rules in redevelopment.

#### **Sign Board License**

Due to continued efforts of AHAR especially Shri. Niranjan Shetty with the Municipal Commissioner and ministers, the Government of Maharashtra has issued a Government Resolution stating that a sign board is not advertisements. Only advertisement attracts license. The sky ad in building does not need any permission subject to certain conditions.

#### **Child Labor matters**

AHAR delegate met Shri. VS Deshmukh MOS, Labor and discussed about the employment of persons between the age of 14 to 18 years in restaurants and submitted its suggestions against the harassment through Child Labor and Juvenile Justice Act by the police. The minister in principal agreed our suggestion of giving 15 days time to the hoteliers to submit the age proof of employees and not to arrest them on spot.
