The Registration, if applicable is compulsory for the hotelier. The hoteliers who have not paid the Service Tax are not eligible for Voluntary Disclosure Scheme. After December the Service Tax Departments are initiating strong action. We have filed our WP for stay. The Hearing is yet to start. Members are advised to make the provision for the Service tax, if payable.

<u>FSSAI</u>

The last date for renewal of FSSAI Licence is expiring on 31.12.2013 is 30.11.2013. Delay in payment will attract penalty of ₹ 100/- per day. After 4.2.2014 no conversion is allowed. Members are advised to renew the FSSAI Licence in time.

#### Minimum Wages

Nagpur High Court has given an interim order to pay 70% of revised minimum wages. The next date of hearing is 25.11.2013. We met the Labour Commissioner **Shri Madhukar Gaekwad** and requested him to direct his officers not to use any coercive measures till the Final verdict of Nagpur case.

#### **Electricity matters in Court**

We have three appeals in Supreme Court and Appellate Board against the TDLR, CSS, and Hike. We need huge fund to appoint good Counsel to defend the case. Our fight should not get stalled because of lack of fund. We need strong financial base.

#### 34th AGM

The AGM on 18.12.2013 is a full day event. We are expecting around 50 stalls. Members should visit from morning and support the vendors in the stalls and also attend General Body in full strength.

2. To get maximum support from our members for any promotional tie up, this will generates more revenue besides the membership and help the Association to sustain its financial Status.

3. To request the members, their friends and well wishers for maximum reach to the Website of AHAR, which will be alternative source of revenue to the Association. We will update the web-

site with all possible informations for the benefit of our members and vendors.

4. To have a strong corpus Fund. Our annual outgoings are around ₹ 30 lakhs, our Membership collection is around ₹ 24 lakhs. The short fall is compensated by the interest earned on funds kept in Corpus Funds. An Association of 34 years is having a corpus of only ₹ 130 lakhs till date. We need at least a base fund of ₹ 500 lakhs to meet any eventualities like challenging the various unjustified laws, rules, regulations, judgments and decisions in court of law to safe guard the interest of the entire hotel industry. We need an average amount of ₹ 30 lakhs per annum to meet these huge legal expenses. He sought the guidance of advisors and support of all members in achieving this target. He also sought a road map to achieve the same from the Advisors.

Shri A. B. Shetty He congratulated all the new committee members and President. The days ahead are very hard. The increase in membership is the need of the hour. It is not only the duty of the VPs but also of each and every member to bring at least 5 new members to ahar fold. The hike in Gas prices affecting hotelier hard and need to get
