Steps to Procure Easy Permit Via Excise Portal

The Concept of Easy Permit aims at providing Drinking Permit easily and without time consuming to the Consumer with all the Security layers and verification. following are the steps involved in the process of generating Easy Permit.

1. Basic data entry provided by the Consumer.
2. Validation/Confirmation by the Consumer.
3. Sending of the Query string to the selected Concern Authority this will enable the verification and Authentication by the concern authority.
4. Receipt of the returns string sent by the concern authority verifying and authenticating the data and providing the required data by Easy Permit.

5. Easy Permit would prompt payment through Secure Socket Layers (SSL) of State Bank of India A/c No- 0039. (This will enable the direct credit of the charges of the easy permit in the State Excise Account.

Once the data is received and compiled and payment is credited the Easy permit is ready for Email an SMS

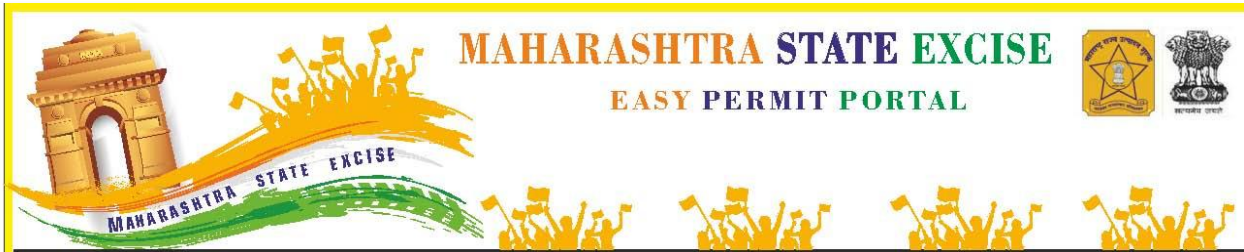
