AHAR Tribute to Late Shri Rao Datta Kadamb, First President

The Indian Hotels and Restaurants Association (AHAR) members paid rich tributes to



Shri Rao Datta Kadamb founder and first President of AHAR.

Shri Rao Datta Kadamb was one of the kindest men ever known in the AHAR and social circle. Born on 1st January 1931 and left for his heavenly abode on September 6, 2015.

Shri Datta Kadamb adorns many feathers to his cap and the prestigious one and the only recipient of "AHAR Jeevan Gaurao Sanman" awarded to him in January 2010 during 30th AGM. Some of his other achievements

Shri Datta Kadamb and his success story from a humble beginning to a business tycoon were featured in many publications and in an interview with AHAR editorial board during October 2010. He narrated his challenge and bottlenecks he faced during his primitive stage in setting up of his first hotel Ajanta (Niagra Restaurant) at Khar at the age of 23 years. Further, he started the much acclaimed Pamposh Restaurant which has given him name and fame. Followed by Sanmaan, Shamiana, Shangrila, Kadamb Residency etc.

He also owns the famous Kadamb Sahyadri Hotel at Lonavala.

Being an innovative and long visionary and the challenges like getting skilled staff, he found a solution to the ever increasing need for quick food he franchised the first McDonalds (Linking Road, Khar) in India. He also has franchises of Baskin & Robbins Ice cream (Linking Road, Bandra), Lavazza-Barista (Linking Road, Bandra) and Café Coffee Day (Carter Road, Khar).

Shri Datta Kadamb was a thorough family man and he always credited his success to his wife and family. He often praised his wife Smt. Sangeeta Kadamb and is blessed with a son Shri Sameer Kadamb, looking after his business and two daughters (Smt. Shilpa and Smt. Swati) are happily married and settled. Shri Datta Kadamb is the eldest of three brothers Shri Shanta Ram Kadamb and Shri Sumit Kadamb who are very closely associated with him.

Shri Kadamb Datta demonstrated a positive and cooperative spirit. This helped AHAR to build a strong team to address various issues and challenges popped up from different quarters.

The main reason for setting up of an Association for Hotel and Restaurant owners were mainly to address various challenges and issues pertaining to the industry.

During those period the Hotel industry was plagued with many problems and issues like shortages of essential

elements etc.

He was instrumental in getting the due recognition from various quarters and to the present status. He was a permanent figure in almost all AHAR meetings and members were looking forward to hear him speak.

Shri Kadamb played a key role in salvaging AHAR from a rival group of who tried to take control of the Association. His thought provoking speech took a new turn and saved AHAR from miscreants.

• Meeting with Jt. CP [Traffic]

A delegation from AHAR met Shri Milind Barambe, Jt. CP, Traffic on August 17, 2015. During the discussion Jt. CP requested for sponsoring the traffic wardens

by the Restaurateurs to cope up with the shortage of traffic police staff. Police will provide all logistic support in handling traffic. Each warden needs to be paid around Rs.10, 000/- salary per month to be sponsored by the hoteliers / Restaurateurs of the area. AHAR officials have submitted a memorandum regarding insistence for parking for new / renewal / transfer of PPEL by Police. Jt. CP assured that the parking will not be insisted for existing premises.






