The Hon. Treasurer briefed the house that to keep alive the in house magazine, it has been decided to support the publisher with subsidy of Rs.1,26,000/- per issue being the 50% of the cost for further four issues by sponsorship or through Advertisements collected through AHAR. He further said we tied up with 6 vendors with package including the advertisements in magazine and hence the amount collected from the advertisements will be given as subsidy to the publisher.

He sought an Approval for an amount of Rs. 5,04,000/- for the next four issues either by cash or reimbursement through advertisements.

Events of the Month President briefed the events of the month as under:

Minimum Wages

So far five hearings are over. The Labour Department has argued that AHAR has never made any representation to the Govt regarding Minimum Wages. AHAR submitted the representations copy to advocate, which will be submitted as annexure. The interim stay is still available to the Hoteliers against the implementation of the revised Minimum Wages in Maharashtra. Members are advised to pay 70% of the amount notified till further directions from the Honorable Nagpur High Court and the balance amount should be kept aside till the case is concluded.

Service Tax

The petition has not come up on Board since the last few months and members are advised to take the guidance from the Association if anyone is served a Notice / Summons.

FSSAI

The petition against clarifications about causes in the FSSAI Act which is detrimental to the industry is pending for further directions. The last date for renewal, registration and new license has been extended by 6 months till 4.8.2014. In case of any notice, please get in touch with AHAR office for guidance.

Meeting with Mr. Sumit Mullik, Additional Chief Secretary, Govt. of Maharashtra

Members may be aware that a petition for simplification of old laws pertaining to the hotel industry was presented to the Government. Subsequently, the Government had appointed

ACCENTURE to prepare a detailed report stating the measures to be undertaken to implement the changes and arrive at a single window system for new / renewal of licenses with minimum conditions to facilitate growth of the Hospitality Industry in the state. The final report was placed in front of Mr. Sumit Mullik, Additional Chief Secretary for further actions to be undertaken by the Government.

On the advice of Mr. Suresh Shetty Minister, we met Mr. Mullik and appraised him about the immediate need to amend the archaic laws pertaining to the hospitality industry. We also shared with him specific instances of undue harassments due to the existence of such rules which are difficult to implement in Present environment. We have informed him about the need to reduce the number of licenses and create

a single window system for better governance. He has assured us of addressing our concerns during the implementation of the Process.

The meeting concluded with an understanding that the Wine Dealers Association will coordinate with Country Liquor Association Wholesale Distributors etc. and AHAR would do the same with Hotel Associations in other Districts of Maharashtra

member's anguishes over the proposed exorbitant hike in license fees. Shri Naik shared our concerns by mentioning that he is always against such unjust over burdening of the business communities. He advised us to meet the Commissioner of Excise with our representation and he would discuss the same with the Commissioner and the Principal Secretary. We met the Commissioner the same evening and explained to him the consequences for the industry due to the proposed hike and requested him to withdraw the same. He in turn informed us that the hike was necessary as it was not done since the LAST FEW YEARS AND THE Government needs resources to implement the popular schemes announced for the benefit of people.

We retorted by stating that the Government would lose revenue if hotels are compelled to close as license fee is collected once a year whereas Government receives various taxes throughout the year and joblessness will increase, creating further impediments to the Government schemes. He advised us to prepare a petition substantiating our claims through proper data for the Government to reconsider the proposed hike. An Emergency meeting was convened the next day to discuss the further course of action and it was concluded by suggestions that an expert opinion should be sought to enhance our presentation for a better result. Through the good offices of Mr. Sunder Shetty we met Mr. Ramakrishnan former Commissioner of Excise for his guidance after sharing the petition prepared by our team to which he contributed a few points and the subsequent detailed petition was delivered to the Chief Minister, Dv. Chief Minister, Excise Minister, Principal Secretary Excise, Commissioner of State Excise and we also requested all our affiliated Associations to do likewise. We also met Mr. Suresh Shetty, Minister at his residence together with Mr. Chandrahas Shetty, Mr Ravindra Arasa and Mr. Chandrashekar Shetty to appraise him about the current crisis and facilitate a hearing with the Chief Minister for saving our members from such a steep hike. We are waiting for a favorable result. We will discuss in detail, obtain the feedbacks of our members, other Associations of Maharashtra, other liquor related Associations and will then decide the future course of action.

With regard to Funds, before we undertake membership drive this year. An earnest effort should be made to clear all the pending unpaid dues from members as benefits were accruing to them on a regular basis.

Next, we need to strengthen our Association by enrolling new members as we have already expanded our tools of communication through Brochures, Magazines, Newsletter and Website.

A PR Agency may be appointed to consistently highlight the industry's views throughout the year for the benefit of members and to reach to the Government and mass visibility.

Office Administration should be upgraded with the help of Systems and Procedures conforming to the present environment through latest standards prevailing in the country.

We need to appoint an Ex-Government official for representing our issues in a judicious way.

Formation of a State level Body to address common issues as the grievances pertains to entire State and addressing in State level is necessary. A reserve fund of at least Rs. five crores should be raised for sustaining our movement and achieving our objective to be the largest and most respected Association representing issues pertaining to the Hospitality Industry.

Briefing by Hon. Gen. Secretary

- An agency is needed to look at our internal and external communication. It will be a full time agency which needed for a regular monitoring and following up the impact. We need fund for such assignment.
- We also require a Social media for movement of news and analysis. To have a bigger picture, branding and visibility of the Association. A Judicious PR can convert our actions and doings visible and far reaching.
- Association job is to fight against the injustice and we will continue the same.

Presentations by Sub Committee Chairmen Committee – Police - Chairman Shri K. V.

Shetty – Briefing: Briefed that he needs one member from Each Zone for his committee. Any Complaints should be in writing and the Committee will decide the course of action after discussions with the aggrieved hoteliers. Whenever meeting the Police officials VP and the affected Hotelier should accompany him for a proper coordination. The format for inclusion of Managers name in PPEL is available at AHAR office.

Committee – Hawkers - Chairman Shri K. K. Mahale – Briefing: Briefed that the WP will be filed soon in illegal hawkers matter. He requested the members and VPs to provide him only list of illegal food hawkers to be included as annexure to the petition.

Committee – Publication - Chairman Shri Bhaskar Shetty – Briefing: He briefed and made an Audio visual presentation of the Website and shown how the details of the hoteliers who is registering will be highlighted. In due course the hoteliers will be given the option of self uploading. He requested the hoteliers to register by payment of Rs.365/- for a year. He also requested the members to visit the website, which has become live and updated regularly.

Committee – Excise Chairman Shri Vijaykumar Shetty (Suburbs) – Briefing: Thanked **AHAR** for electing him as Excise Chairman. He said harassment by a so called activist **Shri Khan** was attended and through the Excise SI was discussed and solved.

Committee – Excise [City] - Chairman Shri Mohan Shetty – Briefing: A matter of demanding of huge favour for transfer of legal license of an hotelier attended, got it done without making any undue favors through the Superintendent of Excise. Committee – Promotion - Chairman Shri

Dhiraj Shetty Thanks for electing me as the Chairman of Promotion Committee. Today we were able to bring 7 stalls of vendors. He said that the members should support the vendors and their products so that more and more vendors' stalls can be brought for every Managing Committee meeting and to the AGM, which is a huge source of revenue for the Association. **Presentation**

Appreciated the suo moto offer by **Shri Manish**, who donated to AHAR and set a trend to be followed by others. The matter for Bank Guarantee instead of Cash Deposits and the period of Deposit should be discussed with MGL authorities. He offered his participation in the meeting. Now, the Association should give more time to matters pertaining to policy matters instead of fighting at lower level. More and more corner meetings should be held for proper interaction and awareness of the happenings. The efforts by VPs like Sunil Patil in meeting the officials to address the grievances of members is a good thing.

Shri Sudhakar Y Shetty

The Efforts of the Managing Committee through representation, meeting etc. with

officials, Ministers regarding FL-III Fees hike are good. Now, we have to decide our course of action in case the hike is not reviewed. In case, we do not fight, in the coming years it may be hiked at will. This exorbitant hike will affect the small hoteliers, many of which may shut down their business or rent out their outlets or sell it. We have to decide and take steps. In case the hike is not reduced, we should resolve and decide that the license should not be renewed and also go for 1-2 days token strike including all liquor vending and selling Associations', other hotel Associations throughout the state. We have to unite and take immediate step. In case of any reduction each permit room hotelier should contribute a minimum of Rs. 10,000 to AHAR's legal fund. In Service Tax matter, if registered keep the collection in separate account. There are many complaints regarding service by SREI and it should be addressed soon. A PR Agency is required for regular follow up in various news matters.
