AHAR delegation to call on Union Finance Minister & Union Health Minister

Shri Anil Salian VP-Zone-X and the host of 10th Monthly Managing Committee Meeting welcomed the delegates to the meeting. He acknowledged the support received from all members over the years in making the Zone a vibrant one. He further said that the membership drive is in full swing and sought the support of all members in renewal and enrolling of new members.

A delegation of AHAR is likely to have an audience with the Union Finance Minister, and the Union Health Minister very soon. The delegation will raise

the intriguing issue of Service Tax during their meeting with the Union Finance Minister. The issue of FSSAI will be the focus of their interaction with the Union Health Minister.

It could become possible after Shri Niranjan Shetty facilitated a meeting of hoteliers with the Union Minister, Shri Ananth Kumar to discuss issues affecting the growth of the industry. The Minister has assured the hoteliers of an audience with the Union Finance Minister & Health Minister during the winter session in Delhi to address our issues pertaining to Service Tax & FSSAI.

"Amongst the various issues including high inflation, outdated laws, multiple taxes we specifically highlighted the plight of the industry due to the levy of Service Tax in A/C restaurants & introduction of FSSAI by the Central Government during our meeting with the Union Minister, AHAR president Shri Arvind Shetty informed while addressing the 10th Monthly Managing Committee Meeting was held on 29 October 2014 at 7.45 p.m. at Hotel Avenue, Thakur Complex, W. Shetty, briefed the house that an amount of Rs. 20 lakh was sanctioned in the earlier monthly meetings to meet the Service Tax legal expenses.

"We moved the Supreme Court by filing SLP, as the Service Tax writ petition was dismissed by Bombay High Court. We have to appointed Ms. Diksha Rai as our advocate on record and Adv. Mr. Arvind Datar as our counsel to file our reply for the affidavit. It may be noted that Adv. Mukul Rohatgi who was our counsel who prepared the draft petition has been appointed as the Attorney General of India by the Government of India.

Both the State & Central Administration have filed their respective affidavits in the Supreme Court. The earlier Single Bench Judgment of the Kerala High Court favoring Hoteliers was challenged by the Service Tax Department in the Division Bench. Now the Division Bench of the same Court has dismissed the appeal of the Department & upheld the earlier judgment stating that bifurcating a bill for the purpose of levying Service Tax is unconstitutional as the entire amount is constituted as sale of Goods & Tax by the State.

The newly introduced FSSAI has clearly mandated repeal of all other

to Food. "We had requested the State & Local Administration to repeal the BMC 394 License as our members were facing a lot of difficulties due to the presence of two different Departments governing the same set of Food Laws. Service Tax Matter

The Service Tax Department's appeal against an earlier Single Bench Judgment on Service Tax favouring Hoteliers is dismissed by Division Bench of the Kerala High Court.

Division bench of Kerala High Court struck down Service Tax on Restaurants and Hotels, held that only States alone have power to impose tax.

The Hon'ble Kerala High Court had earlier held that the levy of Service Tax on Restaurants and Hotels is beyond the legislative powers of Parliament. It was declared that subclauses (zzzzy) and (zzzzw) to Section 65 (105) of the Finance Act 1994 as amended by the Finance Act 2011 is beyond the legislative competence of the Parliament as the said subclauses are covered by Entry 54 and Entry 62 respectively of List II of the Seventh Schedule. The Court had also allowed refund of Service paid by the Petitioners in the stated case. Being aggrieved the Department filed a Writ Appeal before the Division Bench of Kerala High Court.

The Department paced reliance on the subsequent decision of the

Hon'ble Bombay High Court in the case filed by AHAR wherein the Bombay High Court gave a contrary judgment denying the decision of the Kerala High Court and upheld the constitutional validity of levy of Service Tax on AC Bar Restaurants.

The Division Bench of Kerala High Court disposed of the Writ Appeal filed by the Department against the Single Judge's Order and categorically endorsed the analysis of the Single Judge and distinguished the Bombay High Court order.

Free to choose power distributor

After introduction of portability in sectors like mobile phone number as per which a subscriber is free to change his telecom operator according to his choice, the same has now become possible for the power consumers in the Mira Bhayander, Chene and Vasrsova.

The Tata Power Company (TPC)

Landmark Judgments

had filed a petition before the Maharashtra Electricity Regulatory Commission requesting for grant of Distribution Licence under the provisions of Section 15 of the Electricity Act, 2003 and Maharashtra Electricity Regulatory Commission (General Conditions of Distribution Licence) Regulations, 2006. The proposed area of supply falls within the geographical boundaries of the State of Maharashtra.

The Maharashtra Electricity Regulatory Commission, under the powers conferred on it by Section 86(1) (d) read with the Section 14 of the Electricity Act, 2003, has granted licence (s) to persons seeking to act as Transmission Licensee(s), Distribution Licensee(s) and Electricity Trader(s) in the State of Maharashtra. Since Tata Power has applied for grant of Distribution Licence within the State of Maharashtra, this Commission is the Appropriate Commission for this case. Accordingly, the Commission has admitted the Petition and decided the same through an Order.

Display of signboard

There is a good news for the hotels and bars. They can put up illuminated signboards on their premises without paying exorbitant advertisement charges for the same. It has become possible through a petition which had been filed by am AHAR member, Mr. Shivaram Shetty in the Bombay High Court. While hearing the petition, the court referred to a Supreme Court judgment and said that the hotels and bars were free to display signboards on their premises so as to beln their customers locate their premises. However, this order comes with a rider, The hotels and bars have been instructed that the signboards should be in such a manner that they do not invite customers or for any other such commercial gain purposes.

The court said that signboards indicating the name of the business place doesn't amount to an advertisement and therefore the display of signboard will not amount to an offence within the section 328 A of Mumbai Municipal Corporation Act and will not be punishable u/s 471 of the said Act.
