Dear Members,

Please refer PDEXCIL earlier circular dated 05.10.2017 regarding Group participation in 10<sup>th</sup> Colombo International Yarn & Fabric Show 2018. Due to various reasons including comparatively higher participation cost, PDEXCIL has not received sufficient response from our members and the organizers also could not provide any additional support service. Moreover the Fair was targeting only Sri Lankan Buyers, whom we already have good business relation. In view of these circumstances the committee decided to drop participation in the said event and decided to organise an exclusive exhibition cum buyer seller meet, as successfully organised in 2013 and 2017.

You are well aware that Sri Lanka is one of the biggest Garment manufacturing hub in the neighboring country of India. European Union (EU) has granted GSP+ to Sri Lanka for '0' duty imports to EU for Sri Lankan Apparel Exports, w.e.f. 19<sup>th</sup> May, 2017 resulting in a considerable rise in Apparel exports from Sri Lanka to EU. The Garment units are mostly depended on imported fabrics and due to geographical advantage, Indian exporters have a very good potential for enhancing export of fabrics and other textile items to Sri Lanka. The local trade importers/sourcing agencies also looks for good quality of fabrics and other textiles from outside of Sri Lanka. The Export scenario of some textile commodities to Sri Lanka from India is as follows:

PDEXCIL also signed an MOU with Sri Lankan Apparel Exporters Association and it is expected that the fabric exporters from India will be benefitted from this development.

With a view to increase the export of all types of textiles particularly the fabrics being manufactured by the Powerloom entrepreneurs, Powerloom Development & Export Promotion Council (PDEXCIL) has decided to organize an exhibition cum Buyer Seller Meet at Colombo, Sri Lanka under MAI scheme of Ministry of Commerce, GOI.
