#### **INSTRUCTIONS**

(Please read these instructions carefully before submitting application for registration under the Export-Import policy for registered Exporters)

I. Registration with this Council under Export-Import Policy is necessary for claiming export incentives and benefits against export of Powerloom fabrics and made-up items. Membership is to be obtained before registration can be granted. Membership and registration can be applied for simultaneously, but shall be granted separately depending upon fulfillment of requirements.

As per the existing provisions of EXIM Policy, Registration-cum-Membership Certificate (RCMC) can be issued, depending on fulfillment of requirements, as follows;

- a) Merchant Exporter
- b) Manufacturer Exporter
- c) Merchant-cum-Manufacturer Exporter

Please note that the Council shall give RCMC as manufacturer exporter for specific products for which documentary evidence is given.

- II. The Application for Membership & RCMC should be accompanied by the following Details / Documents, wherever applicable.
- 1. Membership Fees payable for New Members is Entrance Fees Rs 2500/- + Rs2300/- (Annual Subscription charges 2000 + Services tax) = Total Rs 4800/- by way of Demand Draft /Cheque in favour of "Powerloom Development & Export Promotion Council" payable at Mumbai.
- 2. Application form for Membership duly filled in.
- 3. Application form for RCMC duly filled in duplicate.
- 4. A photocopy of **Import-Export Code No**. duly attested by the Exporter (for RCMC Only.)
- 5. If an exporter desires to get registered as Manufacturer Exporter, then evidence to that effect is required this is as follows:
  - (a) Please attach a Self attested Photocopy of the valid Registration Certificate issued under the Erstwhile Textiles (Control) order 1986 or Acknowledgement of Information Memorandum under the Erstwhile Textiles (Development & Regulation) order 1992/Current Textiles (D & R) 2001 or a self attested copy of the Form 1A or 1B submitted under the Textile (Development & Regulation) order 2001 issued by the Ministry of Textiles, Govt. of India, along with a declaration by the applicant of having filed the Form 1A or 1B, with the relevant documentary proof and / or the acknowledgement, as the case may be.
  - (b) Any other Government Documents evidencing the Applicant to be a Manufacturer.
- 6. Please attach a self attested photocopy of (i) Partnership deed or (ii) Memorandum and Articles of Association as the case may be (compulsory for membership).
- 7. In case the above referred documents submitted are not in English Language, please submit self certified English translated copy of the Documents.

#### III. RENEWAL

- 1. The Registration Certificate will be valid for a period of five years, ending 31st March of the licensing year subject to continuation of the membership of the council every year. The certificate shall be deemed to be valid from 1st April of the licensing year in which it was issued.
- 2. Renewal of RCMC after its expiry will be considered on submission of fresh application, duly completed as per the Rules & Regulations applicable at the time of making the Application. The expired RCMC in original must be surrendered along with the application.
- 3. Membership must be renewed before 31st May every year. Non-renewal of membership will result in automatic cancellation of RCMC.
- 4. As per Para. 13(a) (i) of the Articles of Association of the PDEXCIL, a member shall cease to be a member if he fails to pay the annual subscription on the expiry of a period of 2 months from the date on which the subscription or dues fall due which shall be **1ST APRIL, EVERY YEAR**. Therefore members are requested to renew their Membership by **31ST MAY EVERY YEAR** not awaiting renewal bill from the Council. Extension of the last date of renewal of membership with the PDEXCIL beyond 31st May, for a further period of 1 month, up to 30th of June every year, on the representation of the member so defaulting, shall be granted by the Secretary subject to FORCE MAJEURE CONDITIONS ONLY. The member shall pay the annual subscription in full, including for the entire period of default within the time stipulated by the Secretary. If Membership is not renewed by 31st May, and for further period, if granted by the Secretary, (subject to Force Majeure Conditions Only), then the membership shall be treated as cancelled.
- 5. Please quote your Membership No. and RCMC No. while doing any correspondence with the Council.

#### **CODE OF CONDUCT FOR EXPORTERS**

- I) We the manufacturers as well as exporters whose manufactures and goods are exported from India, do hereby take pledge that we shall in all our dealings in the international trade strictly abide by and adhere to the principles set are hereunder:
  - 1) We appreciate and value the high ethical standards in business and are convinced in our belief that on such standards a permanent and lasting international trade, between any countries, can be built up. We give this a solemn assurance that we shall abide by and conduct ourselves a in manner that conforms to the high ethical standards in business.
  - 2) We undertake to strictly fulfill all contractual obligations made in good faith between the buyers and ourselves and thereby protect the interest of the buyers and through them of their consumers.
  - 3) We agree to continuously strive to improve our manufacturers and goods and subject to these to any desired or prescribed inspection before packing and dispatching.
  - 4) We undertake that all our stamping and marking on the goods and manufactures will be correctly described their quality and measure.
  - 5) We agree to adhere to the time of delivery specified in our contract as far as it is humanly possible subject to the act of God force majeure.
  - 6) We agree to adhere to contractual specifications, on the basis of samples submitted and approved by the buyer, within internationally accepted trade tolerance.
  - 7) We shall endeavour our utmost satisfy the requirements of the buyers within the contracted stipulations in all respects. If at any stage there is a complaint from the buyer that any of the obligations have not been fulfilled, we undertake to enquire into and settle the complaint promptly and amicably as possible, using where-ever necessary the good offices of Export Promotion Council, Commodity Board, or any other organization which exists in India, for the purpose of promoting and assisting exports, excepting where there is Specific mention in contract of any recognized authority as Arbitrator, in which event we shall abide by the procedure prescribed in the contract.
- II) I / We undertake, without any reservation, to furnish without fail monthly returns of exports including nil returns to the Registering authority by 15<sup>th</sup> day of the months following the quarter.
- III) We further understand that our registration is liable to be cancelled in the event of breach of the undertakings mentioned above.
