**TO ALL THE MEMBERS OF THE PDEXCIL:**

**SUB: ELECTION OF MEMBERS TO THE COMMITTEE OF ADMINISTRATION  
OF THE POWERLOOM DEVELOPMENT & EXPORT PROMOTION  
COUNCIL (PDEXCIL)**

In continuation to the circular no. PDEXCIL MUM/ELECTION/53/2017-18/315 dt.11.07.2017, it is to inform that the scrutiny of nominations including the withdrawal has been completed as scheduled and the returning officer confirmed valid nominations of one candidate against 03 vacancies from Western Region and 04 valid nominations against 04 vacancies from the Southern Region. Accordingly the returning officer declared result of the election leaving **02 seats from western region** vacant.

The Committee of Administration (COA) of the PDEXCIL, now decided to hold the election for those **02 (Two) seats, which falls vacant in Western Region.**

In this regard, the Notice & Schedule for the said election, in Form I is enclosed herewith, for your information and necessary action. **Please note that the contesting candidate should be from Western Region only.**

Each member of the PDEXCIL, who is eligible to vote, can cast one vote for every above mentioned seat to be filled up from the above-stated region. The voting shall be carried out by the members by **electronic voting. Detailed procedure will be intimated along with user id and password being sent on 06<sup>th</sup> September, 2017 as per item 8 of election schedule through email only.**

In terms of Article 19 read with Article 10 of the Articles of Association of the PDEXCIL, all the authorized representatives are empowered to exercise their votes for the election of the members of the COA as well as to stand for election to the membership of the COA. The members of the PDEXCIL as on 30<sup>th</sup> of June, 2017 only shall enjoy the rights & privileges for the above referred elections.

Attention of the members is drawn to rule 5(iii) of the Election Rules of the PDEXCIL which is reproduced herein below:-

“Nominations for election to the Committee of Administration will be filed in the prescribed Form (Form II) to reach the Council's office not later than the date specified in the Schedule referred to above. Please note that this nomination duly completed in all

respect should be accompanied by Demand Draft of Rs.1 lakh as deposit in the case of other than retiring COA members. Nomination forms will be available in the office of the Council including its regional office at Erode. However the duly filled in and signed nomination should be submitted only to PDEXCIL Head Office at Mumbai on or before the scheduled date and time and can be collected by the members any time during office hours".

Thus, as per the above cited rule, nomination forms for these elections should be got collected by the members from the Head office of the PDEXCIL at Mumbai or R.O. Erode, during its office hours. In this light, it may please **be noted that these nomination forms are not being sent by post to the members.**
