#### TO ALL THE MEMBERS OF THE PDEXCIL:

## SUB: ELECTION OF MEMBERS TO THE COMMITTEE OF ADMINISTRATION OF THE POWERLOOM DEVELOPMENT & EXPORT PROMOTION COUNCIL (PDEXCIL)

- 1. The Committee of Administration (COA) of the PDEXCIL, in its 105th meeting held on Monday the 10th July, 2017 decided to hold the election of members to the Committee of Administration of the PDEXCIL as per schedule enclosed in **Form-I** and to hold the 22nd Annual General Meeting (A.G.M.) on the 15th of September, 2017, at Mumbai.
- 2. In this regard, the Notice & Schedule for the election of members to the Committee of Administration, in Form I is enclosed herewith, for your information and necessary action.
- 3. It may further be noted that the total number of seats falling vacant in the COA of the PDEXCIL at the ensuing 22nd A.G.M. are 7 (SEVEN) and these vacant seats are to be filled up through elections from the below mentioned regions as follows;

- 4. Each member of the PDEXCIL, who is eligible to vote, can cast one vote for every above mentioned seat to be filled up from the above-stated regions. The voting shall be carried out by the members by electronic voting including detailed procedure will be intimated along with user id and password being sent on 12th August 2017 as per item 8 of election schedule through email only. Hence, members are requested to ensure that your email id is updated with PDEXCIL, reconfirming the existing email id, which is mentioned on the envelope of this letter or create new one if you do not have email id so far, on or before 09th August 2017, request received after 09th August 2017 will not consider.
- 5. In terms of Article 19 read with Article 10 of the Articles of Association of the PDEXCIL, all the authorized representatives are empowered to exercise their votes for the election of the members of the COA as well as to stand for election to the membership of the COA. The members of the PDEXCIL as on 30th of June, 2017 only shall enjoy the rights & privileges for the above referred elections. The members who wish to change their authorized representative for the purpose of the aforesaid election may do so by informing the Council's head office at Mumbai **upto 05:30 p.m. on 21.07.2017** along with the name and signature of the authorized representative. Kindly note that the aforesaid communication containing the duly amended authorized representative of the members should reach the Council's head office at Mumbai before the receipt of the duly filled in nomination form in the Council's head office at Mumbai.
- 6. Attention of the members is drawn to rule 5(iii) of the Election Rules of the PDEXCIL which is reproduced herein below:-

"Nominations for election to the Committee of Administration will be filed in the prescribed Form (Form II) to reach the Council's office not later than the date specified in the Schedule referred to above. Please note that this nomination duly completed in all respect should be accompanied by Demand Draft of Rs.1 lakh as deposit in the case of other than retiring COA members. Nomination forms will be available in the office of the Council including its regional office at Erode. However the duly filled in and signed nomination should be submitted only to PDEXCIL Head Office at Mumbai on or before the scheduled date and time and can be collected by the members any time during office hours".

Thus, as per the above cited rule, nomination forms for these elections should be got collected by the members from the office of the PDEXCIL, during its office hours. In this light, it may please **be noted that these nomination forms are not being sent by post to the members.**
