Dear Member,

The Cotton Textiles Export Promotion Council is organizing National Level Participation in 'TEXWORLD' and 'Apparel Sourcing' held at Paris Le Bourget, France from 6th-9th February, 2017.

Trade Data:

In the year 2015, EU (28) imported US\$ 109.43 billion worth of T & C from the world, of which, import from India was US\$ 7.74 billion, accounting for 7.07% market share.

European Union (EU 28) as a combined market is the largest importer of Textiles & Clothing (T&C) from India, accounting for 25% of total export of T&C from India during 2015.

Considering the higher spending capacity in EU 28 countries, as a block, it is the single largest market for the Indian export of T&C products. However, only 7 % of total import of T&C into EU was from India thereby offering scope for increasing market share.

To facilitate increasing export fabrics to EU and to provide value added service to the Council members, the Council invites samples of fabrics for display at

the Council's information booth free of cost. Trade enquiries received will be conveyed to respective Members contributing samples.

Samples:

Interested Members are requested to send samples of fabrics for display at the Council's information booth on **non-returnable basis**.

Samples can be full width fabrics of 2 mtrs. length or fabric hanger swatches of 30 cm. width & of uniform length.

Each of the samples should be labeled mentioning complete specs and code number along with price list. Samples will be accepted on first come first basis.

To maintain uniformity in display at the booth, the Council reserves the right to reject samples of irregular sizes.
