Dear Member,

The Council proposes to organize a visit of Trade delegation to Shanghai, China from 23rd to 26th August, 2016 to coincide with 'Inter Textile Home Textile Fair 24-27 August 2016' to meet with leading Chinese manufacturers of Home Textiles who are also in need of imported Fabrics and yarns.

During recent meetings with the Officials of China Home Textile Association (CHTA), it was observed that there is an increasing demand in China for imported fabrics for conversion into Home Textiles. At the request of the Council, CHTA has kindly consented to organize B2B meetings alongside the fair for the Indian delegation.

Tentative program:

23rd August 2016: Arrival at Shanghai

24th August 2016: Visit to InterTextile Home textile Fair and meetings with important exhibitors of Bed & bath linen from China and Hong Kong. 25th & 26th August 2016: B2B meeting with Chinese Textile Cos.

Departure for India on 26th August 2016 evening (or as may be convenient to individual members of delegation).

Participation Fee:

Participation fee is Rs.40,000/- (Rupees Forty Thousand only). Fee includes 3 nights Hotel Stay and local logistics (Air Fare not included). In case the stay is extended, the additional cost will be worked out accordingly.

Last date to confirm your participation is 30th July 2016.

As suggested by the Chinese counterparts, size of the delegation will be approximately 8 to 10 Members only. Texprocil reserves the right to select the final members of the delegation.
