About International Trade Fair:

International Textile Fair-Dubai is UAE's premier platform for fashion fabrics and clothing accessories. After the successful Second Edition of International Textile Fair, in April 2015, the textile industry in the Middle East is already looking forward to the next edition of ITF on 11&12th of October, 2015 which will showcase pre-collection Autumn/winter 2016 and Spring/Summer 2017 highlights.

UAE – INDIA BILATERAL RELATIONS

Bilateral trade between India and UAE has been steadily growing over the years. Both the sides are striving to further strengthen these ties for mutual benefits.

India's exports to the UAE are well diversified and textiles is one of the major items being exported from India to the UAE.

Indian Exports of Cotton textiles to UAE

UAE is one of the leading markets for Cotton textiles.

- India is the largest exporter of Cotton Yarn to UAE with a share of 74.33%.
- India is the Second largest exporter of Cotton Fabrics to UAE next to China with a share of 29.45%.
- India is the largest exporter of Cotton Made-ups to the UAE with a share of 39.77%.
- Exports of Cotton Fabrics from India to UAE in 2014-15 touched US\$ 172.21 Million as compared to US\$ 138.86 Million in 2013-14 registering a growth rate of 24.02%.
- Exports of Cotton Made-ups from India to UAE in 2014-15 touched US\$ 442.85 Million as compared to US\$ 278.90 Million in 2013-14 registering a very healthy growth rate of 58.78%.
- Exports of Cotton Yarn from India to UAE in 2014-15 touched US\$ 12.60 Million as compared to US\$ 14.10 Million in 2013-14 registering a decline by 10.59%.

MDA Benefit to the participants

The event is eligible for financial assistance under the MDA scheme. However, this is subject to the guidelines laid down by the Ministry of Commerce & Industry under the MDA scheme and the fulfillment of the conditions and documentary requirements prescribed by the scheme.

Financial Assistance under MDA to eligible exporters:

UAE falls under the category of General Areas under the MDA scheme and financial assistance of Rs. 150000/- will be available to eligible exporters.

Rs. 1, 70,000/- for a booth of 9 sq.mtrs with the basic facilities.
