Textiles in Iran

- Iran imported US\$ 1.29 billion of textiles & clothing from the world in 2014 of which textiles was USD 1292 million and clothing was only 4 million. India's share in the Iranian textile & clothing market was only 11%.

- Iran's total import of cotton yarn from the world in 2014 was USD 51.63 million. India ranks 1st in supplying all types of yarns (approx. USD 35.35 million) and ranks 2nd in supply of made ups (approx. USD 2 million) and 5th in cotton fabrics (approx. USD 3.19 million).

Trade Data

India rank second with total imports of USD 40.54 million with share of 17.50%.

Financial Assistance under Market Development Assistance (MDA)

The event is covered under MDA and financial assistance will be available to eligible

exporters . Iran is included under WANA countries under MDA . **All eligible members can claim MDA upto maximum eligible grant of Rs.2,00,000/-** towards charges of the built up furnished stall **subject to final approval of the event by the Ministry** and submission of all documents as per prescribed MDA guidelines.

As per revised MDA guidelines, exporting companies with an f.o.b. value of exports of upto Rs. 30 crore in the preceding year will be eligible for MDA assistance for participation. This will be subject to the condition that the exporter has completed 12 months membership with concerned EPC and filing of returns with concerned EPC/ organization regularly. MDA benefit will be available only if a minimum of 10 members participate in the event, subject to fulfillment of all other terms and conditions.

Visa

TEXPROCIL will issue the Visa Recommendation letter to the participants.
