The Cotton Textiles Export Promotion Council with the support of other Textile EPCs proposes to Organize National Level Participation in 'TEXWORLD' and 'Apparel Sourcing' Paris, France 14-17, September, 2015.

It is the Right Fair to meet big buyers of Textile & Clothing in a high value market.

European Union (EU 28) as a combined market is the largest importer of Textiles & Clothing (T&C) from India, accounting for 26.27 % of total export of T&C from India during 2014.

Considering the higher spending capacity in EU 28 countries, as a block, it is the single largest market for the Indian export of T&C products. However only 7.17 % of total import of T&C into EU was from India thereby offering a big scope for increasing market share by undertaking suitable marketing survey, such as participation in this world famous event and meet with major importers in EU.

Bigger booths (in multiples of 3 Sq.Mtrs.) are available on request.

Please note that this fee does not include Airfare, Hotel expenditure, sending display material and other related expenditure. MDA grant will not be available since this event is already subsidized under MAI Scheme.

Standard Booth package includes Shell scheme booth, carpeted flooring, one Table with 3 chairs, 3 shelves of 1 mtr each, one hanger rail of one mtr length 3 focus lights and name fascia.

Corner Booth Premium

Actual fee charged by the organizers will be applicable for corner booth premium i.e. **discount / subsidy is not applicable for corner booth premium.** Due to availability of limited number of corner booths, allocation will be done by Messe Frankfurt, Paris, after considering various aspects as per their own guidelines.

Companies interested in Corner Booth are required to send a separate cheque to the Council along with Application. In case Corner booth is not allocated to interested companies, their cheque will be returned.

VAT

As per new guidelines, certain category of exhibitors are exempted from VAT. In case your Company does not qualify for VAT exemption, equivalent amount need to be paid by you on getting final invoice from the organizers.

GUIDELINES FOR THE ALLOTMENT OF BOOTHS:

Participants who pay the full participation fee in time would be considered for allotment of booths.

1. Considering availability of funds for only 50 booths under MAI Scheme for this event, applications will be considered on First Come First Served basis.
2. The decision of Chairman / ED, TEXPROCIL would be final in case of any confusion / dispute.
3. No change in the booths, once allotted would be entertained under any circumstances.

CANCELLATION

In case of cancellation / withdrawal of participation by Members, participation fees will be forfeited.

APPLICATION

Exporters registered with TEXPROCIL and other Textile & Apparel EPCs can apply for participation in this event. Members are requested to send their application to respective Councils (or) directly to TEXPROCIL with full participation fee by way of Demand Draft / Cheque in favour of "**The Cotton Textiles Export Promotion Council**" (payable at **Mumbai**).

Kindly note, your Application will be considered only if we receive full payment towards participation fee on or before 25th March, 2014.
