As you may be aware, the Government of India has constituted Prime Minister's ambitious skill development programme under the leadership of the National Skill Development Corporation (NSDC). The NSDC mandates skill formation to develop the workforce with enhanced skill through structured programme and assessment.

Owing to the presence of widespread training centres, by both public and private entities, determining the quality of training rendered at different training centres is crucial to the success of skill development programme and, thus, skill assessment is an essential part of skill development.

The Apparel, Made-ups & Home Furnishing Sector Skill Council (AMHSSC) has been launched jointly by the Ministry of Textiles (MoT), National Skill Development Corporation (NSDC) and the Apparel Export Promotion Council (AEPC) with the primary mandate of enhancing and to build a capacity in skill development. One of the salient features of the AMHSSC is designing of training programmes, based on industry demands of different segments and to ensure that all successful trainees are certified through accredited agency.

AMHSSC has been authorized by NSDC for assessing proficiencies in the skills of trainees for the Apparel, Made-ups and Home furnishing sectors in their respective subject areas.

The Ministry of Skill Development and NSDC have recently launched Pradhan Mantri Kaushal Vikas Yojna (PMKVY). Under this scheme, the Training providers/manufacturers affiliated to Sector Skill Council, can be reimbursed with Training cost of

training candidates @ Rs. 10000/- per candidate. In addition to this, reimbursement is given by the Govt of India for assessment and certification of even the existing employees of any Apparel, Made-ups & Home Furnishing units.
