Dear Member,

The Council proposes to organize a visit of Trade delegation to Tashkent, Uzbekistan from 6th to 9th September, 2016 to coincide with FIEO organised group participation of Indian companies at '13th Textile Expo Uzbekistan 7th – 9th September 2016' to meet with leading Uzbek manufacturers of Home Textiles who are also in need of imported fabrics and yarns.

The "Textile Expo Uzbekistan" is a part of a series of specialized textile and fashion exhibitions in the CIS countries. At present this is the only specialized trade exhibition for textiles and fashion in Uzbekistan with international professional participants and visitors. The expo includes a Special Buyer Program since 2011 which includes over 200 major buyers from Russia, Ukraine, Belarus, Kazakhstan, Turkey & other countries. In the last edition, there were over 5500 trade visitors who attended the exhibition. The show is supported by the leading government agencies and industrial associations.

Tentative program:

6th September 2016: Arrival at Tashkent7th & 8th September 2016: Visit to 13th Textile Expo Uzbekistan 7th –9th September 2016 and meetings with important exhibitors.

Departure for India on 9th September 2016 morning (or as may be convenient to individual members of delegation).

Participation Fee:

Participation fee is Rs.35,000/- (Rupees Thirty Five Thousand only). Fee includes 3 nights Hotel Stay and local logistics (Air Fare not included). In case the stay is extended, the additional cost will be worked out accordingly.

Last date to confirm your participation is 3rd August 2016.
