This is to inform you that India Trade Promotion Organisation (ITPO) is organising 18th edition of Tex-Styles India' 2017 from February 21 – 24, 2017 at Hall 11, Pragati Maidan, New Delhi after the successful revival of Tex-Styles India 2016. Tex-Styles India showcases the Indian textile industry with a visually aesthetic display of the complete range that India offers to the world.

Tex-Styles India, one of the leading trade shows for Textiles Industry in India, has witnessed an excellent turnout of business visitors, in its previous editions as well as buying agents representing prominent importers from different parts of the world.

The 2016 edition, revived after a gap of five years, was organized with 65 companies from the entire gamut of textiles, from yarn to garments. The Show was visited by around 1600 business visitors including 300 overseas buyers and buying agents from 40 countries including Australia, UK, USA, Canada, UAE, Philippines, Russia, Malaysia, Nepal, Bangladesh, Japan, Korea, Hong Kong, Pakistan, Singapore, Ghana, etc.

Textile Gifts - Fabulous Textile Gifts ranging from Home Decorative to Fashion Accessories.

Trims & Accessories - Shawls, Tussels, Laces, Threads and other embellishments to enhance the look & feel of the modern apparel and furnishings.

Support Services - CAD/CAM Systems, Colour & Trend Forecasts, Trade Publications and support services for the Textile & Furnishing industry.

ITPO plans a publicity campaign in overseas markets to reach out to the buyers/ importers. Indian Missions will be involved in identifying companies sourcing from India and mobilizing visitorship to the event.

The participation charges for 'Tex-Styles India 2017' fair are Rs. 6500/- per sq. mtr for shell scheme (Minimum bookable area is 9 sq. mtrs) and Rs. 5500/- per sq. mtr. for bare space (minimum bookable area is 18 sq. mtrs) . Catalogue entry charges of Rs. 3500/- are compulsory. Shell scheme includes built up booths in octonorm system, with adequate furniture, display aids, carpet and fascia. NOTE: Service Tax chargeable on all the services as per existing Govt. rules
