Sub: <u>Inviting participation in B2B program alongside "2015 China Home Textile Conference" 24-26 November 2015</u>

Dear Member,

This refers to the Council's circular No 114 dated October 23, 2015 inviting participation in "2015 China Home Textile Conference" to be held at Nantong on 25th and 26th November 2015.

Focus of the Conference is "Internet Plus & Smart Home Textiles".

More than 300 Chinese Home Textile Manufacturers are expected to attend this Conference and participation at the Conference will give an opportunity for the Indian supplier of raw material to meet with a large number of yarn and fabric importers at one location.

Considering the importance of supply of Yarn and Fabrics to the Chinese Home Textile manufacturers, the China Home Textile Association (CHTA) has kindly consented to organize a B2B program between the Indian suppliers of Yarn and Fabrics with Chinese manufacturers of Home Textiles. Summary of Program for the event is as follows:

24th November 2015: Registration

25th November 2015: Morning: Visit to Home Textile market at Nantong.

Afternoon: B2B Program:

Presentation by representatives from Pakistan, Vietnam and India followed by a combined B2B meeting with Chinese Home Textile Manufacturers and importers of yarn and fabrics.

26th November 2015: Whole day Conference. Only those interested Members may attend the Conference.
