**Sub: Service Tax on Renewal Subscription of Membership.
New Registration and other services provided by the Council**

Dear Member,

Increase in Service Tax w.e.f. 1st June, 2016:

As regards Service Tax, it may kindly be noted that as per Union Budget 2016, **Krishi Kalyan Cess** will be levied @ **0.5%** on all taxable services effective from June 1, 2016. Hence, the total applicable service tax will be 15% w.e.f. 01.06.2016.

We request all our members to pay Service Tax @ 15% on the renewal subscription.

Those who have already paid their renewal subscription may kindly ignore this mail.

Annual Renewal Subscription:

The **Annual Renewal Subscription** for the financial year 2016-2017 has become due for payment from 1st April, 2016, as follows:

Member	-	Rs.10,000/-	+ 15% Service Tax	=	Rs.11,500/-
RTE	-	Rs. 5,000/-	+ 15% Service Tax	=	Rs. 5,750/-

Special Discount on Renewal Subscription:

TEXPROCIL's **special discount scheme** for those who wish to renew their membership for a period of 3 or 5 years is as follows:

[RTEs and Members have to pay service tax on the discounted amount @ 15%.]

New Registration:

Member - Rs.16,000/- + 15% Service Tax = **Rs.18,400/-**
RTE - Rs.8,000/- + 15% Service Tax = **Rs. 9,200/-**

Other Services:

Service tax applicable on other services like Export Performance Certificate, Turnover Certificate, Certificate of Origin, MDA Processing Fees, Advertisement at Market Place, Website & E-Newsletter, etc. will also be increased from 14.5% to 15% on account of Krishi Kalyan Cess @ 0.5% over and above Service Tax and Swachh Bharat Cess.
