The Cotton Textiles Export Promotion Council (TEXPROCIL) proposes to organize India Pavilion in 16th Vietnam Int'l Textile & Garment Industry (VTG) exhibition from 23rd-26th November 2016 at the Saigon Exhibition & Convention Center (SECC), Ho Chi Minh City, Vietnam.

VTG is organized by Ministry of Industry & Trade Vietnam National Trade Fair & Advertising Joint Stock Company (VINEXAD) and sponsored by VITAS- Vietnam Textile & Apparel Association, AGTEK – Association of Garment – Textile and VCOSA – Vietnam Cotton & Spinning Association.

## Vietnam Textile & Clothing Industry

Vietnam is among top 5 nations in the world in exporting garments and hence offers very good opportunity for increasing exports of yarn & fabrics.

In 2015, Vietnam imported about 24.13 USD bn worth of textile and clothing of which approximately USD 19.15 bn was in textiles. India's share in the textiles imports was just USD 394 mn. In cotton textiles, Vietnam imported almost USD 6.05 bn of which India's share was just 2.06 % amounting to USD 125 mn. Import of cotton fabrics from the World contributed the highest share within the cotton textiles import basket with USD 5.24 bn and India ranked 8th with USD 37.55 mn.

### MDA Benefit to the participants:

This event is eligible for financial assistance under the MDA scheme. However, processing of MDA claim is subject to the guidelines laid down by the Ministry of Commerce & Industry under the MDA scheme and the fulfillment of the conditions and documentary requirements prescribed by the scheme.

Vietnam falls under the category of Focus ASEAN Area under the MDA scheme and financial assistance will be available upto a maximum limit of Rs.1,50,000/-.

### <u>Cancellation / withdrawal policy:</u>

In case of cancellation / withdrawal of participation by Members, participation fees will be forfeited as follows:

- Less than 30 days prior to start of the event: 100%
- 30 45 days prior to start of the event: 75%
- 46 days or earlier to the start of the event: 50%
