Sub: Inviting participation in COLOMBIATEX, 26-28 January, 2016

Dear Member,

The Council proposes to organise group participation in COLOMBIATEX, 26-28 January, 2016 being held at Medellin City, Colombia.

Colombiatex is the largest fair in South America for Fibre to Fashion, the entire Textile value chain, attracting buyers from all over LAC region to source their requirement of Textile & Clothing.

The Council invites members to take advantage of this event to gain further access into the Colombian market.

Textile and Clothing industry in Colombia:

The textile and apparel sector is one of the most important sectors in Colombia. It has a business track record of over 100 years and generates approximately 6,50,000 direct and indirect jobs, representing 14% of total employment in the manufacturing sector. The sector represents 11% of manufacturing GNP and 1.8% of national GNP.

With several bilateral and multi lateral regional agreements, import of yarn and fabrics into Colombia keep increasing in recent years, for conversion and re-export as well as for domestic consumption. Recently concluded Free Trade Agreement (FTA) between Colombia and USA has prompted several Chain Stores in USA to increase their sourcing from Colombia, thereby offering a greater scope for supplying yarns and fabrics to Colombia for conversion.

Colombia accounts for 6.5% of imports of Cotton Textiles in the LAC region. India is the 2nd largest supplier of Cotton Textiles with a share of 22%.

It may be noted that, Colombia imported US\$ 2.4 Billion worth of Textile & Clothing, of which import of Cotton Textiles was US\$ 610 million in the year 2014-2015. Cotton Fabrics dominate the import market with a share of 64% followed by Yarn and Made-ups.

Convention Center Plaza Mayor, Medellin, Colombia (White Pavilion Aisle)
26th to 28th January, 2016

Participation Fees:

Participation fees for a standard stall of 9 sq.mtrs. is Rs.2,96,000/- only.

Owing to limited space availability, larger booths are NOT available in India Pavilion.

Participation fees includes standard built up stall of 9 Sq. Mtrs, 3 Spotlights, Fascia Sign, Power Point, 1 Table and 3 Chairs, 1 Clothes Rail, 3 Shelves.

Please note that, this fee does not include airfare, hotel expenditure, sending display material and other related expenditure.

We await MDA or MAI approval from the Government for this event. If the Ministry grants approval with financial support, appropriate amount will be refunded to participating companies as per applicable MDA or MAI guidelines.

Exhibitor Profile:

Producers and traders of textiles, Textiles and Apparel Supplies Manufacturers and traders, textiles and Apparel equipment and machinery, Raw materials, and specialized services.

Promotion:

An extensive pre-event publicity will be undertaken by the Council with support from the Embassy of India and Chamber of Commerce & Industry in Colombia.
