Sub: Inviting Participation in Delegation to China, 25 and 26 August 2015

Dear Member,

The Council proposes to organise a visit of Trade delegation to Shanghai, China from 25th to 26th August 2015 to coincide with 'Inter Textile Home Textile Fair 26-28 August 2015' to meet with leading Chinese manufacturers of Home Textiles who are also in need of imported Fabrics and yarns.

During recent meetings with the Officials of China Home Textile Association (CHTA), it was observed that there is an increasing demand in China for imported fabrics for conversion into Home Textiles as well as certain types of Home Textiles. At the request of the Council, CHTA has kindly consented to organise B2B meetings for the Indian delegation.

Tentative program :

24th August 2015: Arrival at Shanghai

25th August 2015 Afternoon: B2B meetings with leading Chinese manufacturers of Home Textiles.

26th August 2015: Visit to InterTextile Home textile Fair and meetings with important exhibitors of Bed & bath linen from China and Hong Kong.

Departure for India on 27th August 2015 (or as may be convenient to individual members of delegation).

Participation Fee:

This is one of self-financing programs being organised by the Council. All the travel / stay related expenses to be met by the participating Members. However, the Council will help booking Hotel rooms at a special tariff.

In addition, **a participation fee of Rs 20,000** (Rs Twenty thousand only) will be charged per delegate to partly meet common expenses, such as, local transport arrangement,

networking meet etc.

Last date to confirm your participation is 27th July 2015.
