**Dear Member,**

The Council proposes to organize India Pavilion at '**Yarn Expo**' & '**Intertextile Shanghai Apparel Fabrics**' being held concurrently from 11 to 13 October, 2017 at Shanghai, China.

**Yarn Import into China**

- China imported 1,972 million kgs of Cotton Yarn (valued at US\$ 5,128 Mn) from all sources in the year 2016, of which, import from India was 415 Mn Kgs valued at US\$ 1,046 Mn.
- India is the 2nd largest supplier of Cotton Yarn to China with a market share of 20%.

**Fabric Import into China**

- Even though China is the largest manufacturer of Fabrics in the World, it also imported US\$ 7,676 Mn worth of Fabrics (of all fibres) in the year 2016. Whereas, share of India was only US\$ 84 Mn [1.11%], thereby indicating large scope to increase India's market share with suitable marketing strategy.
- Considering ever increasing production cost, including cost of raw material, power, labour cost etc., China is increasingly sourcing certain varieties of fabrics from other competitive countries.

**GUIDELINES FOR THE ALLOTMENT OF BOOTHS:**

All the participants who pay the full participation fee on time would be considered for allotment of booths:

1. Applications will be considered on FCFS basis.
2. Booth Number allocation will be on alphabetic order.
3. For the allotment of booths, where any vacancy arises after allocation, the same would be allocated to waitlisted companies.
4. No change in the booths, once allotted would be entertained under any circumstances.
5. The decision of ED, TEXPROCIL would be final in case of any confusion/dispute.

**MAI funding**

In accordance with the recent amendments in the MAI guidelines and conditional approval from the Ministry of Commerce, applicable subsidy will be reimbursed subject to the following important criteria:

- Those exporters who have already availed subsidised fee structure under MAI scheme for 3 or more times including past participation can participate by paying full participation fee.
- An exporter can avail subsidised participation fee in a maximum of 2 approved MAI events in a financial year.

**CANCELLATION**

In case of cancellation / withdrawal of participation by Members, participation fees will be forfeited as follows:

Less than 30 days prior to start of the event: Up to 100%

30 - 45 days prior to start of the event: Up to 75%

46 days or earlier to the start of the event: Up to 50%
