Record Import of Vegetable Oils during Oil Year 2012-13 – Up by 4.77% Refined oil import jumped to double since April 2013

Import of Vegetable Oils during Oil Year 2012-13 (Nov.'12 to Oct.'13) i.e. edible oil and non-edible oil reached at record level of 106.8 lakh tons compared to 101.9 lakh tons for the same period of last year i.e. up by 4.77%.

Import of Vegetable Oils during October 2013:

Import of Vegetable Oils during October 2013 is reported at 1,021,973 tons compared to 1,036,107 tons for Oct.'12 i.e. slightly down by 1.36%.

The total import of vegetable oils i.e. edible oil, non-edible oil and vanaspati for the year 2012-13 (Nov.'12 to Oct.'13) is reported at 106.8 lakh tons compared to 101.9 lakh tons last year. There is no import of vanaspati since last 4 years.

The overall import of vegetable oil has increased by 4.9 lakh tons (4.77%) during oil year 2012-13(Nov.-Oct) over the previous year. The main reasons for increase in import of vegetable oil are:

- The overall production of veg.oils was stagnant at 80.9 lakh tons compre to 81.5 lakh tons in i) previous year.
- ii) Local consumption of edible oils further increased due to increase in per capita consumption (3%) and population growth (1.76%). Also lower price of veg. oils boosted the consumption of veg. oils.
- iii) Due to inverted export duty structure by Indonesia and Malaysia, import of RBD Palmolein substantially increased during the year. Import of refined palmolein during April to October 2013 jumped to over 16.0 lakh tons compared to 7.5 lakh tons during the same period of last year.
- iv) Closing stock of imported veg. oils as on 31st October decreased to 14.0 lakh tons compared to 15.7 lakh tons as on 31st Oct.,2012.
- v) Import of non-edible oil gradually reduced from 6.5 lakh tones (2007-08) to 2.1 lakh tones in 2011-12 due to higher local refining of CPO. However in 2012-13. Import of non-edible oils increased due to reduction in local processing of CPO.

Stock at Ports & Pipelines down:

Stock of edible oils as on 1st November, 2013 at various ports estimated at 520,000 tons (CPO 260,000 tons, RBD Palmolein 85,000 tons, Degummed Soybean Oil 110,000 tons, Crude Sunflower Oil 60,000 tons, Rapeseed Oil 5,000 tons) and about 880,000 tons in pipelines. Total stock, both at ports and pipelines is reduced and estimated at 1,400,000 tons compared to 1,465,000 tons in previous month.
