Dear Sir,

Record Import of Vegetable Oils during Oct., 2015 and Oil Year 2014-15 – Up by 23.64%

Import of vegetable oils during Oil Year 2014-15 (Nov.'14 to Oct.'15) i.e. edible oil and non-edible oil set a new record level of 146.1 lakh tons (14.61 MnT) compared to 118.2 lakh tons (11.82 MnT) for the same period of last year i.e. **up by 23.64%**. Oil year 2014-15, has set a new record for highest import of palm products as well as soft oils like soybean, Sunflower and Rapeseed (canola) oils.

Import of Vegetable Oils during October 2015:

Import of Vegetable Oils during October 2015 is reported at 1,670,891 tons compared to 1,245,915 tons for Oct.'14 i.e. up by 34%. Import of edible oil in October 2015 is the highest import in any single month since allowed in OGL in 1994. Similarly import of Palm Products during Oct.'15 is the highest in any single month.

Import of Vegetable Oil (Edible & Non-edible Oil) & Vanaspati:

The total import of vegetable oils i.e. edible oil and non-edible oil for the year 2014-15(Nov.'14 to Oct.'15) is reported at 146.1 lakh tons compared to 118.2 lakh tons last year. There is no import of Vanaspati since last 6 years.

The over all import of vegetable oil has increased by 27.9 lakh tons (23.64%) during oil year 2014-15 (Nov.-Oct) over the previous year. In 2014-15 import of palm oil increased by 15.7 lakh tons and reported at 95.4 lakh tons compared to 79.6 lakh tons in 2013-14. Soft oil import jumped to 48.8 lakh tons from 36.6 lakh tons in 2013-14. India has imported highest quantity of soybean, sunflower and rapeseed oils this year due to its attractive price. The main reason for overall increase in import of vegetable oil are:-

- Local consumption of edible oil further increased due to increase in per capita consumption (4.5%) and population growth (1.76%). Also lower price of veg. oils boosted the consumption of veg. oils.
- Oilseed production reduced due to deficit rain in last two years, resulted in to lesser availability of oils in the country.
- Excess supply of veg. oils in international market coupled with low price, boosted import.
- NIL export duty by Indonesia and Malaysia also boosted their export to India.

Stock Position at Port and in Pipelines :-

Current stock of edible oils as on 1st Nov., 2015 is the highest. Stock at various ports is estimated at 1,020,000 tons (CPO 530,000 tons, RBD Palmolein 140,000 tons, Degummed Soybean Oil 220,000 tons, Crude Sunflower Oil 80,000 tons and 50,000 tons of Rapeseed (Canola) Oil and about 1,350,000 tons in pipelines. Total stock at ports and in pipelines increased to 2,370,000 tons from 2,240,000 tons in Oct.,2015. India's monthly requirement is about 16.0 lakh tons against which currently holding stock over 23.70 lakh tons equal to 44 days requirements.

Import of edible oil has sharply increased in last few years due to stagnant oilseed production and rising demand in the country. India's dependence on imported oil has increased to 70% of its requirements.

Import of Palm & Soft Oil Ratio:-

During Oil Year 2014-15(Nov-Oct) Palm Oil import increased to 95.37 lakh tons compared to 79.58 lakh tons during the last year and the same time soft oil import also increased to 48.84 lakh tons, consisting of 29.86 lakh tons of soybean oil, 15.42 lakh tons of sunflower oil, 3.56 lakh tons of rape oil compared to 36.60 lakh tons during the same period of last year.

Average Prices and Rupee depreciation :-

In last one year, CIF Indian port prices of edible oils (except sunflower oil) moved downward in line with fall in international prices. RBD Palmolein price is down by US\$ 128 (- 18%) Crude Palm Oil by US\$ 142 (- 20%) and Crude Soybean Oil by US\$ 97 (- 12%), **In last one year rupee is depreciated by 5.9%.**


