2) Scaling up Edible Oil Fortification**


FSSAI has issued Order - File No. 12(2)2017/FBO Representation/Enf/FSSAI dated 14th Nov.'17 permitting the use of pre-printed packaging material containing old name, address, license number on payment of nominal fee.

FSSAI has also issued Order - File No. GRP/EOF/Fortification/01/FSSAI-2016 dated 14th Nov.'17 permitting the use of pre-printed packaging material with label discrepancies involving the fortification of vegetable oil with Vitamin A or Vitamin D till 31st December 2017 subject to condition that the level of fortification shall be as per the FSS(Fortification of Foods) Regulations, 2016.

Subject: Scaling up Edible Oil Fortification- reg.

Sir/ Madam,

The Food Safety and Standards Authority of India vide File No. 11/03/Reg/Fortification/2014 dated 17.11.2016, operationalized the draft Food Safety and Standards (Fortification of Food) Regulations, 2016 which was made effective from 16.10.2016, wherein standards for fortification of vegetable oil with Vitamin A or Vitamin D has been prescribed. This regulation was further operationalised with revised milk standards vide letter no 11/03/Reg/Fortification/2014 (Pt-I) dated 19.05.2017.

2. Industries involved in fortification of Oil were exempted with label discrepancies for the fortified vegetable oil w.r.t label claim and the actual levels of fortification vide this office letter No. 12(3) 2016/Edible Oil/RCD/FSSAI dated 28.03.2017 valid till 05.08.2017.
3. Several representations have been received for further extension of the said directive so as to exhaust the existing inventory available with the concerned FBOs.
4. In view of the above, it is decided to extend the time period for label discrepancies involved in the fortification of vegetable oil with Vitamin A or Vitamin D till 31.12.2017 subject to condition that the level of fortification shall be as per the FSS(Fortification of Foods) Regulations, 2016.

Subject: Representation from FBOs seeking extension for permission to use pre-printed packaging material - reg.

FSSAI vide Order No. 12(2)2016/FBO Representation/Enf/FSSAI dated 23rd November 2016 prescribed the procedure for granting permission to FBOs for use of pre-printed packaging material containing the old name, address or license number of the FBO at a nominal fee on receipt of formal request.

2. It is clarified that at a time, extension shall be granted for six months and a maximum of three such extensions for use of pre-printed packaging material shall be granted. The fee structure for extension shall be as under:

Fee	Central License	State License
1 st Extension (6 months)	Rs. 7500/-	Rs. 3000/-
2 nd Extension (For next 6 months)	Rs. 15,000/-	Rs. 6000/-
3 rd Extension (For next 6 months)	Rs. 15,000/-	Rs. 6000/-
