No. P. 15014/1/2011-PFA/FSSAI- The following draft of certain regulations further to amend the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, which the Food Safety and Standards Authority of India, with previous approval of Central Government, proposes to make, in exercise of the powers conferred by clause (e) of sub-section (2) of section 92 of Food Safely and Standards Act, 2006 (34 of 2006) is hereby published as required by the said sub-section (1) of section 92, for the information of all persons likely to be affected thereby; and notice is hereby given that the said draft regulations shall be taken into consideration after the expiry of a period of thirty days from the date on which copies of the Official Gazette in which this notification is published, are made available to the public;

Any objections or suggestions which may be received from any person with respect to the said draft regulation within the period specified above shall be considered by the Authority;

Objections and suggestions, if any may be addressed to the Chief Executive Officer, Food Safety and Standards Authority of India, FDA, Bhawan, Kotla Road, New Delhi 110 002.

Draft Regulations

- I. (1) These regulations may be called the Food Safety and Standards (Food Products Standards and Food Additives) (Second Amendment) Regulations 20 12.
 (2) They shall come into force from the date of their final publication in the Official Gazette.
- 2. In the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, in regulation 2.2 relating to "FATS, OILS AND FAT EMULSIONS", -

- (a) in sub-regulation **2.2.2** relating to 'Interesterified Vegetable Fat', after the words "interesterification of the essentially neutral edible oil or fat, singly or in mixtures generally through", the words "enzymatic process or" shall be inserted;
- (b) in sub-regulation **2.2.6** relating to HYDROGENATED VEGETABLE OILS,

(i) in clause (1),-

(A) after the words "a process of hydrogenation in any form", the words "or physical, chemical or enzymatic interesterification" shall be inserted;

(B) after the item (u), the following shall be inserted, namely:-"(v). Palm Stearin";

(C) in sub-clause (vii) for item (b) and entry relating thereto, the following item and entry shall be substituted namely:-"(b) Trans fatty acids, not more than ten per cent, by weight";

(ii) in clause (2), for sub-clause (a) and the entries relating thereto, the following sub-clause and entry shall be substituted, namely:-

"(a) Trans fatty acids, not more than ten per cent, by weight";

(c) in sub-regulation **2.2.5** relating to MARGARINE AND FAT SPREADS, in clause (2), for sub-clause(ii) and the entries relating thereto, the following sub-clause and entries shall be substituted, namely:-

" (ii) Trans fatty acids, not more than ten per cent, by weight".

Any objections or suggestions which may be received from any person with respect to the said draft regulations within the period specified above shall be considered by the Authority:

Draft Regulations

- I. (1) These regulations may be called the Food Safety and Standards (Packaging and Labelling) (Second Amendment) Regulations, 2012.
 - (2) They shall come into force from the date of their final publication in the Official Gazette.
- 2. In Food Safety and Standards(Packaging and Labelling) Regulations, 2011,-

(a) in regulation 2.2 relating to 'Labelling', in sub-regulation 2.2.2 relating to 'Labelling of Pre-packed Foods', in clause 3, in sub-clause (v), after item (iii), before the provisio, the following shall be inserted, namely:¬

"(iv) Edible vegetable oils, fats including hydrogenated vegetable oils, and processed and packaged foods with declared shelf life will have the following declaration on the label:

(i) Total trans fat content =per cent b	by weight
---	-----------

(ii) Total saturated fat content =per cent by weight";

(b) in regulation 2.4 relating to 'Specific Requirements/Restrictions on manner of labeling', in sub-regulation 2.4.2 relating to 'Labelling of edible oils and fats', in clause 4, after sub-clause (b), the following shall be inserted, namely:-

"(c) Contains	Trans fatty acids	percent by weight, and
	Saturated fatty acids	- percent by weight".
