Cotton – Indian Scenario

- No. 1 in cotton cultivation area (105 lakh hectares in 2016-17) amounting to 36% of global cotton cultivation area
- No. 1 in cotton production (350 lakh bales in 2016-17) accounting for 25% of global cotton production
- India has rich legacy and tradition in cotton
- Second largest producer of cotton yarn
- About 40-45% of textiles consumed in India are of 100% pure cotton

Cotton – Indian Scenario

- Provides direct livelihood to 6 million farmers in the country
- About 40- 50 Million people employed in cotton processing & its trade taking into account cotton related/allied activities
- Indian Textile Industry is predominantly cotton based
- Indian textile trade, dominated by cotton, contributes 4% to GDP
- Important commodity in the economic growth of the country

Problems Faced

- High cost of cultivation
- Poor quality of seeds and pesticides
- Multiplicity of cotton varieties leading to rampant mixing
- Improper handling of harvested cotton at farm yard
- Poor infrastructure at market yards and ginneries
- High level of trash and contamination in ginned cotton

Ginning Scenario – The Past

- Ginneries were in primitive condition and running with poor efficiency with very old machines manufactured in the early 20th century
- In Australia, USA & other countries machine picked seed cotton with more than 25% trash leave ginneries with hardly 1-2% trash
- In India, hand picked seed cotton with substantially less trash left the ginneries with higher trash than the other countries
- Contamination in farm yard, market yard, ginnery & transportation increased in Indian cotton in the 90's of the last century
- Best Indian varieties occupied prime place in the list of "most contaminated cotton" compiled by ICMF

Govt. Initiatives – Technology Mission on Cotton

- To address the needs of the cotton sector, Govt. of India launched Technology Mission on Cotton (TMC) in the year 2000
- The focus of TMC were

Modernization of Ginneries

- Modernization of ginneries was focused on the following four major areas
 - Essential machines including ginning machines, pre cleaner, lint cleaner, kapas & lint conveyor system, bale press etc.
 - Essential infrastructure including, kapas platform, lint halls, bale & seed storage space, CC road, boundary wall / fence etc.
 - Essential conditions including variety / grade wise heaping, head gear, trained fitters, quality awareness boards etc.
 - Desirable machines including HVI, lab gin, GP balance, moisture meter, roller grooving machine etc.

Status of Modernization

- Ginneries underwent a qualitative transformation under TMC and later under TUFS
- Out of estimated 2200 ginneries in the country, about 1400 1500 factories have been modernized / newly setup factories, through TMC, TUFS, Financial Institutions such as banks
- However , the ginneries present a wide spectrum of modernization
- Some factories met just the minimum level of modernization prescribed by TMC / TUFs and others far exceeded the minimum norms
- There is further scope for improvement in modernization, good manufacturing practices and quality of cotton

Star Rating Scheme

- To sustain and augment the benefits of modernization, Govt. of India proposed a rating scheme for ginneries.
- Accordingly, Textiles Committee launched a Star Rating Scheme for ginning & pressing factories in the year 2009
- The objectives of Star Rating Scheme are
 - Encourage modernization
 - Promote quality culture through good manufacturing practices
 - Quality improvement at raw material stage
 - Create a brand for clean cotton

What is Star Rating

- Rating is the process of placing modernized ginning & pressing units into different classes based on the objective assessment of
 - The quality of infrastructure comprising machinery, and civil structural items
 - Management practices including contamination in ginned cotton
- Under the Scheme, ginning & pressing factories are assessed awarded five levels of rating from 'Single Star' to 'Five Star'
- The quality of cotton processed in a ginnery will greatly depend on the excellence of its infrastructure & work practices
- Hence, Star Rating will be a performance indicator for the ability of a ginning & pressing factory to provide clean cotton

Rating methodology

- Modernized G & P factories fulfilling prescribed minimum eligibility requirements can seek rating
- An onsite assessment is carried out in the factories seeking Star Rating
- During on site assessment the following parameters are assessed & assigned marks based on their technical merits

Rating methodology

- A marking scheme has been developed to assign marks to each of the infrastructural & management parameters
- Five levels of criteria has been defined for each infrastructural parameter for assigning mark from 1 to 5
- Three levels of criteria has been defined for each management parameter for assigning mark from 1 to 3
- Each parameter is assigned a weightage representing the extent of its influence on cotton quality and the weighted marks are arrived for each infrastructural management parameter


Rating methodology

- Additional requirements of modernization have also been prescribed for higher Star Ratings of Four Star and Five Star
- Star Rating to a assessed factory is awarded based on
 - Fulfillment of minimum eligibility requirements
 - Marks obtained in infrastructure & management practices
 - Level of fulfillment of additional requirements
- A Certificate of Rating is issued to a assessed and rated factory indicating the Star Rating awarded to that factory
- A factory that dos not qualify for any rating in the assessment will be kept under provisional rated status till it fulfills the rating criteria

Five Classes of Rating

- The five classes of rating from highest to lowest are
 - TC Five Star
 - **TC Four Star**

Validity of Rating and Surveillance

- Star Rating once awarded is valid for 3 years
- A mid-term surveillance visit will be conducted within the validity period to ensure that the machinery, civil infrastructure and management practices continue to be in place
- The Star Rating is renewed after the validity period by conducting a renewal assessment.

Star Rating Scheme Performance

- The response from the ginning & pressing factories to the star-rating scheme was overwhelming
- The user industries, spinning mills, have also welcomed the initiatives for rating of modernized ginning & pressing factories
- Out od the estimated 1400 1500 modernized factories about 80% of the factories have enrolled for assessment & rating so far
