


## RULES AND REGISTRATION FORM FOR PARTICIPATING EMPLOYERS

As per their location selected to meet /interview candidates to whom interview tokens are issued. No other activity other than recruitment related shall be allowed in the job-fair arena.
- Participating employers are NOT ALLOWED to give traveling allowances /reimbursement to any candidate to maintain level playing field.
- Organizer shall exchange information to respective parties as received from other side, we shall not guarantee the authenticity or Performance of any candidate or employer or shall be liable in any manner, we are only offering a common platform for meeting.
- Incase of cancellation or absenteeism from employer -No charges shall be refunded.
