## DO'S & DON'T'S

## All Exhibitors must Strictly Adhere to the following Rules & Regulations :

- Fair Timing will be from 10.00 A.M to 9.00 P.M. on 13<sup>th</sup> & 14<sup>th</sup> July 2016 and from 10.00 A.M. to 8.00 P.M. on 15<sup>th</sup> July 2016
- 2. <u>SMOKING IS STRICTLY PROHIBITED</u> in the Entire Exhibition Area including the Cafeteria & Toilets.
- 3. PHOTOGRAPHY IS STRICTLY PROHIBITED in the Entire Exhibition Area
- 4. <u>ANY PERSON BELOW THE AGE OF 18 YEARS WILL NOT BE PERMITTED TO</u> ENTER THE FAIR AREA.
- 5. Garments / Textile brought into the Exhibition Area will not be permitted to be taken outside the Exhibition Hall till the end of the Exhibition.
- 6. Stalls 12, 15, 16, 18, 24, 28, 30, 32 & 35 Sq. Mtrs. including Corner Stalls, will have only <u>ONE SIDE OPEN</u> and Three Sides will be kept Compulsory Closed. The Maximum Height permissible for these Stalls will be 8 Ft. to maintain uniformity. No Decoration will be permitted inside the Stall. Only Flex, Standees, Mannequins, Posters of the Brand etc. can be used inside the Stall for Decoration.
- 7. Stalls 40, 42, 48, 49, 56, 84, 90, 96, 98 & 112 Sq. Mtrs. will only be allotted Bare Space and will be permitted to Construct & Decorate their Stalls. The Maximum height permissible for these Stalls will be 11 Ft. Construction of Bare Space Stalls must be Completed by 10:00 A.M on 12<sup>th</sup> July 2016 and Dismantling of Bare Space Stalls will only be Permitted after 10:00 P.M on 15<sup>th</sup> July 2016. Decoration Materials such as Thermocole, Tyres, Dry Grass etc. will not be Permitted to be used as Material for Decoration of the Stalls.

- 8. Exhibitors cannot keep any Furniture, Display Material, Mannequins, Standee etc. outside the Stall or in the Passage Way.
- 9. Exhibitors are permitted to bring their own Racks, Stands and Mannequins for their use in their Stalls. Racks, Stands and Mannequins can also be hired from the Agencies who have been Empanelled by the Association.
- 10. No **INFLAMMABLE MATERIAL** will be permitted to be used by the Exhibitors in their Stalls.
- 11. No Decoration will be permitted outside the Stalls or in the Passage Way.

## 12. NO MUSIC WILL BE PERMITTED IN THE STALL.

- 13. Flood Lights and Halogens are Strictly not allowed in the Stalls as they are Fire Hazard and reduce the effectiveness of Air Conditioning thereby causing inconvenience to all.
- 14. The Decision of the Fair Sub Committee on the Exhibitors Booth / Stalls Erection and in all Aspects of the Organization of the Fair will be Final and Binding on all Exhibitors.
