

**67TH NATIONAL GARMENT FAIR

Dear Exhibitor,

AS YOU ARE PROBABLY AWARE THAT, FOR THE FIRST TIME, THE JULY EDITION OF THE NATIONAL GARMENT FAIR WILL BE A NO DECORATION FAIR. ALL EXHIBITORS WILL BE ALLOTTED SHELL SCHEME STALLS ONLY AND NO BARE SPACE WILL BE ALLOTTED TO THE MEMBERS IN THIS FAIR.

The Fair Sub Committee has however decided to permit the Following Relaxations in the Norms for Decoration of the Stall for this Fair.

- 1. ALL STALLS, INCLUDING CORNER STALLS, WILL HAVE ONE SIDE OPEN ONLY. THE MAXIMUM PERMISSIBLE HEIGHT FOR ALL STALL WILL BE 8 FEET ONLY TO MAINTAIN UNIFORMITY. EXHIBITORS WILL BE PERMITTED TO USE FLEX & POSTERS OF THEIR BRAND ETC TO DECORATE THE WALLS OF THEIR STALL. ONLY THE WOODEN/ ALLUMINIUM FRAME REQUIRED TO MOUNT THEIR FLEX WILL BE PERMITTED TO BE MADE IN THEIR STALL. NO OTHER CARPENTARY WORK, POLISHING OR PAINTING WILL BE ALLOWED INSIDE THE STALL. USE OF THERMOCOL, COTTON, GRASS ETC OR ANY INFLAMMABLE MATERIAL WILL ALSO NOT BE PERMITTED INSIDE THE STALL**
- 2. EXHIBITORS WILL BE PERMITTED TO BRING THEIR OWN FURNITURE, PRE ASSEMBLED PROPS, DECORATIVE RACKS, STANDS & MANNEQUINS, LCD MONITORS, ETC. EXHIBITORS WILL ALSO BE PERMITTED TO INSTALL LED WALL IN THEIR STALL WITH PRIOR INTIMATION & PERMISSION FROM THE CMAI OFFICE PROVIDED IT IS SELF STANDING (PROVIDED IT DOES NOT TAKE ANY SUPPORT OF THE SHELL SCHEME WALL) AS THE SHELL SCHEME WALL WILL NOT BE ABLE TO SUPPORT THE WEIGHT OF THE LED WALL. EXHIBITOR WILL ALSO HAVE TO INFORM THE CMAI OFFICE OF THE ADDITIONAL POWER LOAD REQUIRED FOR THE LED WALL AND SHALL HAVE TO PAY FOR THE ADDITIONAL POWER LOAD.**
- 3 Exhibitors can Install their own Lights but are requested to USE LED LIGHTS instead of **FLOOD LIGHTS AND HALOGEN LIGHTS** in the Stalls as they reduce the effectiveness of Air Conditioning thereby causing inconvenience to all.**
- 4 SOFT MUSIC WILL ALSO BE PERMITTED IN THE STALL PROVIDED IT DOES NOT DISTURB / CAUSE ANY INCONVENIENCE TO THE FELLOW EXHIBITORS. THE ASSOCIATION RESERVES THE RIGHT TO ASK THE EXHIBITOR TO STOP PLAYING THE MUSIC IF IT RECEIVES ANY COMPLAINT OF DISTURBANCE / CAUSING INCONVENIENCE TO THE FELLOW EXHIBITORS.**

- 4 **ANY PERSON BELOW THE AGE OF 18 YEARS WILL NOT BE PERMITTED TO ENTER THE FAIR AREA.**
- 5 **Garments / Textile brought into the Exhibition Area will not be permitted to be taken outside the Exhibition Hall till the end of the Fair.**
- 6 **Exhibitors cannot keep any Furniture, Display Material, Mannequins, Standees etc. outside the Stall or in the Passage Way.**

The Decision of the Fair Sub Committee on the STALL DECORATION and in all other Aspects of the Organization of the Fair will be Final and Binding on all Exhibitors.
