**63RD NATIONAL GARMENT FAIR

Dear Friend,

As you are aware, the Constructed Stalls (40 Sqm -112 Sqm) are never Ready on time in spite of our Repeated Requests to all our Exhibitors to ensure that the Stall Construction is Completed in time to enable the Exhibitors to bring in their Samples for Display at the Fair.

The Exhibitors have also been Requesting the Association that the Air Conditioning should be Switched on the Set Up Day for their Comfort but unfortunately the NSE Authorities Refused to do so as the Construction of Stalls is still in Progress in the Halls.

The Association has taken a serious Note of the same and from the 63rd National Garment Fair to be held between 13th & 15th July 2016, Strict Norms are being put into place on all Stall Designers / Contractors who are Empanelled with the Association.

The Norms that are to be Strictly Followed by the Stall Designers/Contractors are as Under :

- 1) The Maximum Number of Stalls that can be Undertaken for Decoration / Construction by a Stall Designer / Contractor has been Restricted to 8 Stalls.
- 2) All Stall Designers / Contractors have been informed that the Construction Work of the Stall should be Completed in all Respects by 10.00 A.M. on July 12th 2016.
- 3) All Stall Designers / Contractors have now been asked to Deposit an Interest Free Refundable Security Deposit of Rs.750=00 Per Sqm with the Association. In case the Construction of the Stall is not Completed in all Respect by 10.00 A.M on 12 July 2016, the Interest Free Security Deposit shall be Forfeited by the Association and the Stall Designer/Contractor shall not be Empanelled with the Association for the Next 3 Years.

- 4) All Stall Decorators / Contractors have been asked to Submit the List of Stalls that will be Undertaken by them alongwith the Interest Free Refundable Security Deposit to the Association by 30th June 2016.

We have also been facing a lot of Problem with Regard to the Supply of Electricity as Members Utilise more Electricity than the Prescribed Limit. The Association has decided that all Exhibitors who draw Excess Supply of Electricity will have to Pay for the same on per KW Basis. Your Request for Extra Electricity should therefore, be sent to the Association in Writing On or Before 30th June 2016. The Charges are being Worked out by the Association and the same will be intimated to you in due course.

Friends, it is my Request to all my Fellow Members to please Co-operate with the Association and ensure that your Stall is Completed in all Respect by the Stall Designers / Contractors by 10.00 A.M on 12th July 2016. This will help us in getting the Air Conditioning Switched on in all the Halls for the Comfort of all Exhibitors.

I also Request you to kindly Finalise your Stall with the Stall Designers / Contractors by 25th June 2016 so that they could Submit their List to the Association by 30th June 2016. Please also Adhere to the Limit of Electricity Supply for your Stall.

I would also like to inform you that these Deadlines will not be Extendable and Look forward to Your Cooperation to make the 63rd National Garment Fair a great Success.
