### STATE AWARD TO EXPORTERS OF MAHARASHTRA Specimen Application Form.

The awards shall be open to all registered exporters in Maharashtra State in the following categories:-

1. Large Scale Manufacturer Exporters (Export performance of their factories located in Maharashtra State only).
2. Micro, Small. Medium Enterprises Manufacturer Exporters (Export performance of their factories located in Maharashtra State only).
3. Merchant Exporters (Whose Head Offices are located in Maharashtra State only excluding recognized export houses and Government of India and State Government Organizations).
4. Recognized Export House in Maharashtra.
5. Trading House
6. Regional Awards to Small Scale Manufacturer Exporters from six regions in Maharashtra.
7. State Government Corporations.
8. Service Exporters

The award would be for the export performance during the financial year 2016-17 However exporters will have to furnish separate applications for each year of awards. **Last date of receipt of application** by the Directorate of Industries, Mumbai or by the District Offices is **08.02 2018**.
