## Rules & Regulations of Participation

### 1. Participation

Tex-Styles India 2016 will be held at Pragati Maidan from February 22-24, 2016. Timings of the fair will be from 10.00 AM to 6.00 PM daily. Companies desirous of participating in the Fair are required to submit an application for participation, Catalogue Entry Form, Application for Advertisement in Official Fair Catalogue (optional) with requisite participation fee to ITPO.

### 2. Payment

50% participation fee is payable along with the Application. Balance 50% is payable by December 31st February 2016. All payments are to be made by Bank Draft/RTGS in favour of India Trade Promotion Organisation, New Delhi. Banking charges, if any, are to be borne by the applicant.

### 3. Space Allocation

Allocation of space will be made by ITPO on "First-cum-First-Served" basis. Applications completed in all respect and accompanied by requisite payment will only be considered for allocation of space. Acceptance of application will be confirmed by the organizer. Space will be allocated to exhibitors/companies by name and no sub-letting will be allowed in any manner. ITPO reserved the right to select participants/exhibits to be displayed at its sole discretion.

**Retail sale:** No retail sale will be permitted during the Fair. Exhibitors found making retail sale will be penalized & debarred from participation.

### 4. Possession of Stall/Booth

**Shell Scheme:** Constructed stand, using octonorm system with carpets, will be made available to participants one day before the opening of the fair. Possession of stalls will be given against payment of all dues to ITPO. The stalls shall be constructed with prefab octonorm system with a height of 2.5 mtrs. Each panel will be 1 mtr. Wide with white laminated boards.

**Bare Scheme:** Those companies who wish to erect their own stand will be given bare space from the afternoon of 19th February 2016 (after approval of plans for the bare space). If any exhibitor fail to take up the stands allocated to him, ITPO reserved the right to use the stand so unoccupied as they think fit and the exhibitor shall not have any claim in this regard. The decision of ITPO will be final & binding in this regard.

### 5. Furniture/Fittings

Each exhibitor under shell scheme will be provided furniture (counter, round table and chairs), spot lights, power point, waste paper basket, fascia, exhibitor badges, etc. depending on the area booked. Additional furniture, stand fittings, hangers, lights, podiums and items like refrigerator, TVs, videos, mannequins, etc can be obtained on rental basis.

6. ITPO will not be responsible for any damage to exhibits due to natural calamities like rain, thunderstorm etc.

7. ITPO will provide general security in the Hall. ITPO will not be responsible for any pilferage of exhibits, personal belongings of exhibitors like briefcases, handbags, mobile phones etc. from the individual handbags, mobile phones etc. from the individual stalls of exhibitors. Participants, if they so desire, may make their own security arrangements during the exhibition hours.

8. Following facilities will also be provided free of cost to participants:

- Meeting/Business rooms in the hall
- Mineral water
- Daily cleaning of stalls
- First-Aid
- Information Counter at various points
- General Security

### 9. Refund

No refund of participation fee will be made by ITPO after receipt of application. Also if the balance participation fee is not received by the stipulated date, ITPO shall have the right to cancel the participation and initial booking amount paid by the company will be forfeited.

### 10. Vacation of Space

Dismantling of stands will start from 7.00 pm on the last day of the Fair and the space will be vacated by the mid-night of February 24, 2016 positively failing which participants will be liable to pay double of the space rent to ITPO.

### 11. Violation of rules

In the event of violation of these rules by any participant, ITPO shall have the right to close down the stall of the participant concerned immediately.

### 12. Interpretation

The decision of CMD, ITPO or his nominee shall be final and binding on the participants on the interpretation of these Rules & Regulations of participation.

### 13. Disputes

Disputes, if any, arising out of participation in this fair shall fall within the jurisdiction of the courts in Delhi/New Delhi.
