The Indian Merchants' Chamber is pleased to announce that it is taking a **Business Delegation to Tehran, Iran, from May 13-17, 2016** as per the following details:

Itinerary:

- **Friday, May 13, 2016 – Dep from Mumbai at 14.00 hrs – Arrival in Tehran 17.10 hrs**
- **Saturday, May 14, 2016 – Business Meetings with Iran Chamber of Commerce**
- **Sunday, May 15, 2016 – Business Meetings with Tehran Chamber of Commerce**
- **Monday, May 16, 2016 – Sightseeing in Tehran**
- **Tuesday, May 17, 2016 – Dep from Tehran at 07.05 hrs – Arrival in Mumbai 12.00 hrs**

We have planned this business delegation to Iran because we believe there is vast potential for doing business with Iran. The recent lifting of sanctions on Iran has given a renewed impetus to India-Iran bilateral relationship.
