Sub: Issuance of Certificate of Origin under various Trade Agreements

Textiles Committee has been issuing Certificate of Origin (Form A) under GSP Scheme for various countries since 1971 and Certificate of Origin under Indo-Japan Comprehensive Economic Partnership Agreement (IJCEPA) since May, 2014. Now, the Directorate General of Foreign Trade (DGFT), vide Public Notice No. 67/2015-2020 dt. 30.03.2016, has authorized Textiles Committee to issue Certificate of Origin for textiles and made-ups under the following Trade Agreements:

1. ASEAN - India Free Trade Area (AIFTA)
2. Asia - Pacific Trade Agreement (APTA)
3. Global System of Trade Preferences (GSTP)
4. India - Chile Preferential Trade Agreement (ICPTA)
5. India - Korea Comprehensive Economic Partnership Agreement (IKCEPA)
6. India - Malaysia Comprehensive Economic Cooperation Agreement (IMCECA)
7. India - Mercosur Preferential Trade Agreement (IMPTA)
8. India - Singapore Comprehensive Economic Cooperation Agreement (ISCECA)
9. India - Sri Lanka Free Trade Agreement (ISFTA)
10. SAARC Preferential Trading Arrangement (SAPTA)
11. South Asian Free Trade Area (SAFTA)
