The group has manufacturing of synthetic fabric on water-jet looms, synthetic and blended fabrics on rapier and air-jet looms, manufacturing of furnishing yarns (used in carpets), manufacturing of value-added yarns (e.g. Sized yarn – Cotton &amp; Synthetic, texturized yarn, crap yarn etc.), split yarn, non-woven fabric and yarn dyeing. Group also has trading business of yarn and fabric and has four wind mills to cater the power requirement which is catering approx. 30% of the power requirement of the group. Headquarter of the group is located at Surat City and manufacturing sites are at Kim, Karanj and Kosamba locations.</p> <p>We are the leading manufacturer of man-made fabrics. We believe in quality and commitment for long term growth of the group. We have installed capacity of 1.25 lac meters of grey fabric per day on water-jet looms, air-jet looms, and rapier looms. We are manufacturing export quality products of ply furnishing yarn, intermingled yarn, fabrics for shirting- suiting-furnishing-technical textiles etc. major production of which exported to various countries / continents.</p> <p>The Group is also engaged in developing industrial parks and created milestone in development of Textile Park in Surat District. The group has successfully completed Sayan Textile Park, Fairdeal Textile Park and developments of other parks (i.e. Shahlon Textile Park, Jayraj Textile Park, Karanj Textile Park, Tadkeshwar Infra LLP &amp; Yes Greentex Infra LLP) are in progress at various stages.
