Expression of Interest

West Bengal Trade Promotion Organization (WBTPO) invites expression of interest for Empanelment of Agencies for Fabrication, Event Coordination, Temporary Structure Creation and Technical Arrangements at Biswa Bangla Mela Prangan from the exhibitors and organizers of who book space at Biswa Bangla Mela Prangan. **Only the empaneled agencies will be allowed to work in BBMP.**

'Biswa Bangla Mela Prangan' is the primary exhibition and convention Centre for Kolkata, India. With "Project Area" of 89,030 sq.m which include 31,894 square metres (343,300 sq ft) of exhibition space, it is the largest exhibition center in Kolkata.

Built in 2008 to provide space for exhibitions and fairs, BBMP was the venue of Kolkata International Book Fair. With an expense of approx. INR 350 Cr, the state government has transformed this old large expanse of open space to a state-of-the-art facility spread over 22 acres of land. This revamped facility has been added with:

- Two pavilions (over lakh square feet each),
- A three-storey business block (each floor spread over nearly 20,000 square feet) and
- An open space that includes around 2 lakh square feet of greenery.
- A new multi-level car parking to accommodate approx. 1,200 vehicles.
- A large expanse of open space with green landscape in front to accommodate 200 kiosks.
- Three food courts, each of which can accommodate approx. 200 visitors.

The interested agencies are advised to carefully read the Terms and Conditions contained in this EOI.

The applications submitted by the intending agencies will be evaluated as per the norms laid down in this regard. WBTPO reserves the right to accept/reject any or all offers at its sole discretion without assigning any reason whatsoever and the same will be binding on the applicants.

2) Offer

The empanelment will be on the basis of license fees

I) **Annual Empanelment Fees** - Rs 250000/- plus taxes as applicable.

II) **Event wise fees** - a) Rs 20000/- for one hall; b) Rs. 40000 for Two Halls, Taxes as applicable will be additional.

III) **Security Deposit**– Rs. 200000/- to be paid as Security Deposit within 15 days of empanelment. *This will be refunded at the end of empanelment.*

3) Scope:

- The list of empaneled agencies will work as fabricators, event coordinators, technical support providers for the different exhibitors.
- Supply of necessary furniture and fixture.
- Construction of stalls, stage and set up, brandings and temporary structures
- Electrical, Sound and Digital Display set up
- Cleaning and Housekeeping. Garbage and wastes must be thrown at the demarked places.

- Construction and Dismantling as per guidelines of WBTPO.
- All empaneled must ensure to construct, execute and dismantle as per guidelines of WBTPO.
 - The empaneled agencies must set up /temporary construct as per norms of WBTPO, including electrical, sound and technical set up.
 - They must ensure full care while using the facilities of BBMP. They must not cause any damage/loss/theft of any premise or property of BBMP while executing events. Damage of property will lead to deduction from Security Deposit.
 - All exhibition items and wastes must be cleared from the sites of BBMP within the dismantling period. **Failure to vacate space within stipulated time will lead to penalty of Rs. 10000.**
- They must abide to all fire guidelines. Storing of combustible items is not allowed.
- Collection of necessary licenses/permissions.
- Agency must instruct their labours not to litter BBMP while execution.
- Detailed guideline will be mentioned in our empanelment letter.
- Agency must refrain from doing any unlawful activities and refrain from having child labour.
- Agency must clear payment of fees before event and collect Clearance from WBTPO.
- No permanent construction is allowed.
 - Do's and Don'ts will be mentioned in the empanelment letter.

4) Eligibility Criteria:

- a) The agencies must be in the similar business for 10 years.
 - b) The agencies must have Average Annual Turnover for **Rs.1.5crore**for 3 years.
 - c) The agencies must have **single workorder/invoice of Rs. 1 CRORE**and above for being event manager/fabricator etc. in the last 3 years or 3 orders of Rs.50 lakhs over the last 3 years.
 - d) The agencies must be registered and have valid Trade License.
 - e) The agencies should be registered under GST and PAN.

5) Tenure: The selected agencies will be empaneled for 1 year.

6) Payment: The selected agencies must submit their annual renewal fee within 10 days from being empaneled, through online mode to WBTPO and the receipt shall be submitted. The event specific is to be submitted to WBTPO and collect permit to operate.

c. A company incorporated under the Indian Companies Law i.e. the Companies Act 1956 or 2013 (as amended or re-enacted and restated and notified from time to time), (copy of certificate of incorporation, and charter documents including the most recent Memorandum and Articles of the Association of the Applicant should be submitted).

d. Limited liability partnership duly incorporated under the Limited Liability Partnership Act, 2008.

e. Partnership firm registered under the Indian Partnership Act (copy of registered partnership deed should be submitted, including any amendments or supplements thereto).

f. A registered Proprietary firm in India.

g. JV/ Consortium having maximum 2 (two) business entities.

h. PAN and GST certificates.

i. Work order copy for being event manager/fabricator.

j. Copies of Income Tax Return, GST returns and other statutory applicable returns filed in previous three Financial Years

k. Audited Financial Statements of Last three Financial Years . If audit is not completed, CA certificate is required for certifying the turnover.
