

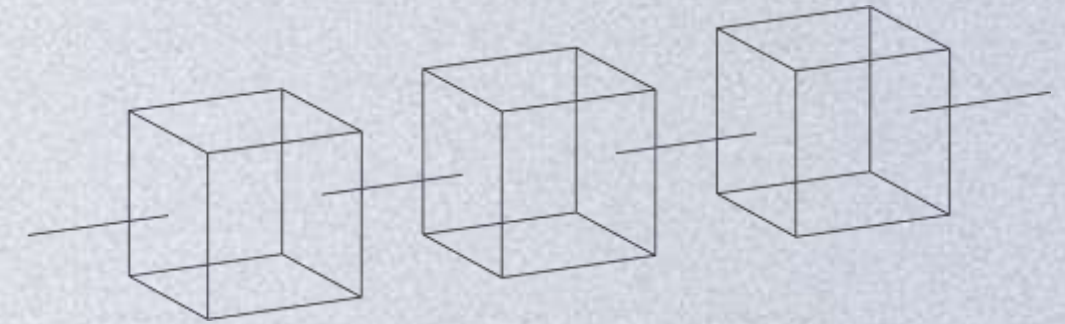
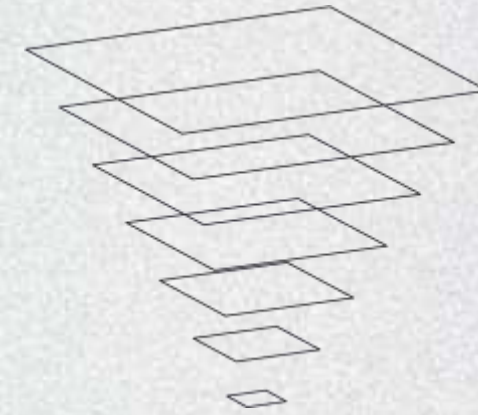
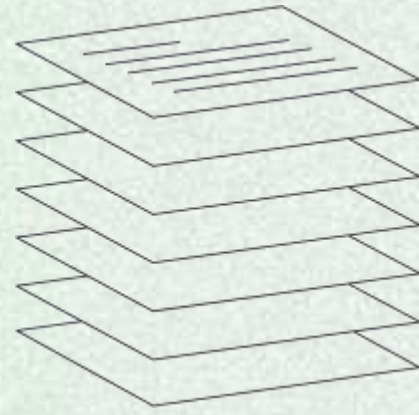

Advance Cargo Information filing for customs

The Advance Cargo Information procedure provides customs authorities with information about cargo ahead of cargo arrival to the country of importation. It enables them to optimize their workflows, shipment pre-clearing, and documentation checks before shipments depart from the country of origin.

If the CargoX Platform is used for ACI, customs departments no longer have to depend on importers' declarations. Instead, each document can be traced easily back to its origin, straight to the issuer of the document, thanks to the CargoX technology based on public blockchain.

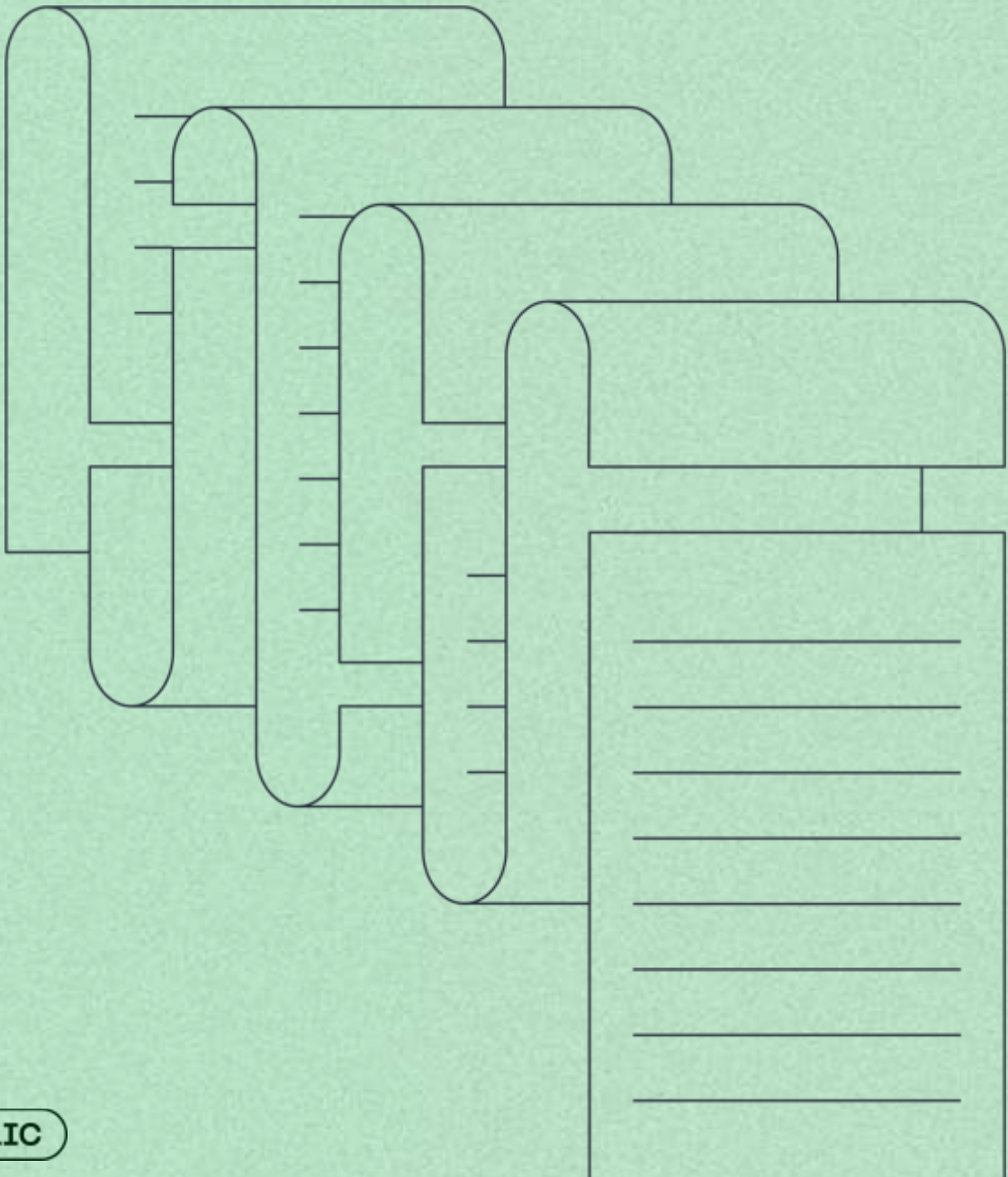
Such pre-processing brings numerous benefits for all participants. It primarily results in **lower daily workloads** on customs officers, **clear visibility** of incoming shipments, and the ability to establish **green lanes for known customers** with a proven track of records and simplified clearance processes upon shipment arrival.

On **yellow and red lanes**, customs officers can perform additional documentation or **physical checks of incoming shipments**.

The ACI procedure helps resolve congestion on customs processing locations and terminals or seaports due to improved predictive workload planning and organisation.

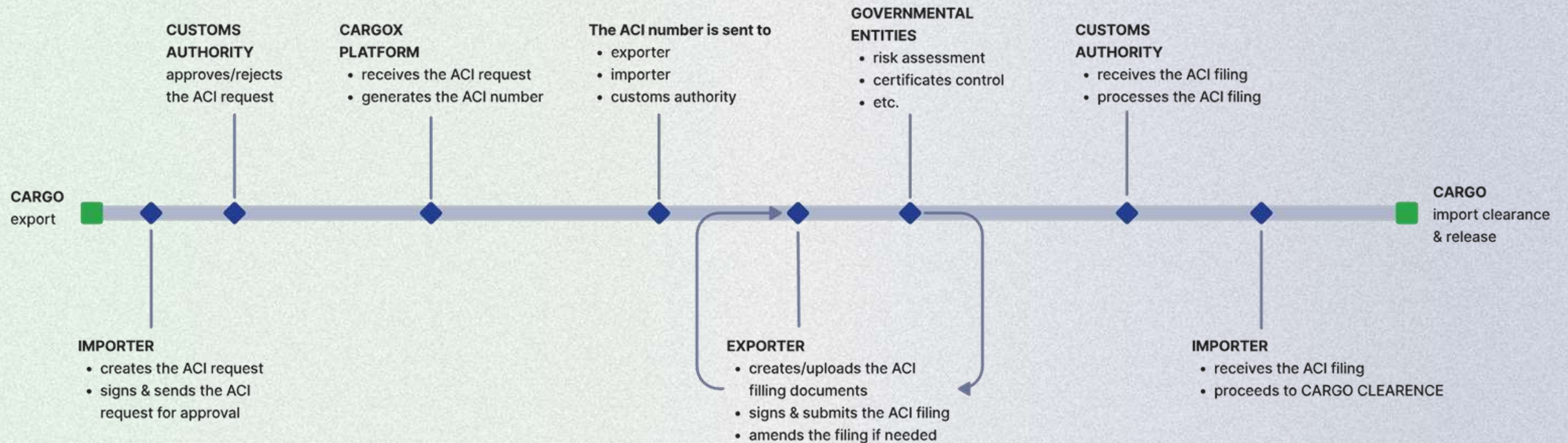

An **additional revenue stream** for the Government



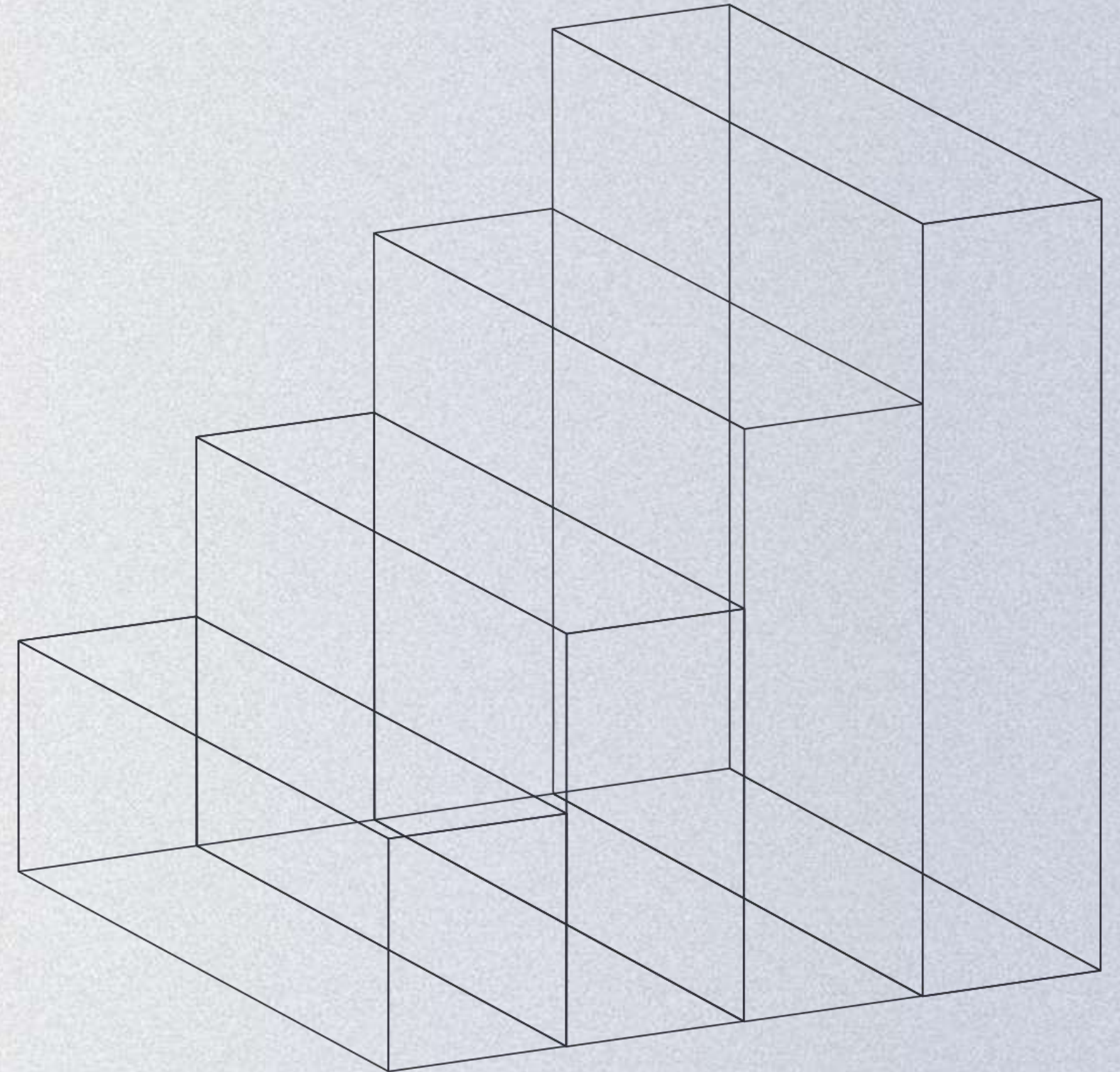
Government
