A global perspective on the future of RoO

- The fragmentation and complexity of the international trading system is increasing and the importance of RoO will increase as well
- There are new areas where RoO may be used to enforce trade policy measures as sanctions and environmental policies. Ex Carbon Border adjustement Mechanism
- Multiple FTAs with hundreds of PSROs is an increased challenge for firms and especially SMEs
- The impact of IT on RoO: Are they really providing a solution?
- There is proliferation of websites on RoO
- The prospects are bright for those making a living from RoO...





Any prospect for intergovernamental action?

- The WTO agreement on Rules of origin does not contain multilateral provisions on RoO nor there is any prospect in the near future
- Negotiations at WTO in the CROs are mainly on RoO for LDCs: the current debate focus on a report to the General council where the views are diverging
- Will a new mandate to the CRO will emerge?
- A proposal on transparency of non-preferential RoO is on the table since 2019
- Work at WCO on RoO are taking place in the TCRO with a limited mandate
- The updating of annex K of revised Kyoto convention supported by EU, China Japan, New Zealand, Norway, Eurasian Customs Union, UNCTAD is a valid plurilateral initiative: will it succeed?





Are megaregional FTAs providing a solution?

- The new trend of mega-regionals is often welcomed as a tool to simplify RoO and related administrative procedures
- RCEP has been branded as providing a common RoO platform replacing the spaghetti bowl of ASIAN FTAs
- However recent studies* have shown that RCEP does not provide incremental value over and above the existing FTAs
- Firms are profit driven, unless megaregionals offer better preferential margin and RoO firms will continue to use previous FTAs
- Rules of origin and administrative procedures in Megaragionals are the result of compromises among many partners involved in difficult negotiations and rarely offer best practices and models.

What an IGO can do?

- UNCTAD will continue its advocacy and research on RoO with partners WTO, WCO, ADB
- UNCTAD and European University Institute have established a research community and round table of experts: Next appointment in spring 2024

Areas of research:

- Convergence on drafting product specific rules of origin
- Studies are undergoing with ADB to show potential areas of PSROs convergence across FTAs in Asia

- Among 5 FTAs examined AANZA holds the highest number of convergences with the least stringent PSRO (a count of 3276, at the six-digit level).
- Objective is to show to Governments that PSROs could be simplified towards convergence

Expanding the coverage and feature of the UNCTAD website on utilization rates


- At present UR data on Canada, EU, US, Japan under GSP
- Next step progressive inclusion of URs of FTAs of EU, US and Japan
- Seeking partnerships with RECs such as COMESA, ALADI, ASEAN to include south-south URs

Identify Best practices on proof of RoO and certification:

- A study and survey with ADB in Vietnam
- The objective is to get governments and administrations to introduce trade facilitation reforms in Asia
