An Environmental Impact Assessment (EIA) is a planning tool used in Malaysia since 1988 to govern and study the impacts of development and industrial related projects. It has since evolved to allow the country to study consequences of developments, be it logging, mining, development, industrial and various other sectors on our environment. The EIA approval conditions have then formed the basis for legal compliance of the findings of the EIA to be implemented.

This training will give participants an in depth understanding of Environmental requirements in Malaysia and to understand the importance of being a good consultant utilising good hard and soft skills.

The training will be interactive, with case studies, active participation and informal discussions. The participants will be encouraged to talk more via group discussions and presentations.
