GENERAL GUIDELINES FOR MEMBERS

1. Language of deliberations and written communications: American (US)English.
2. Original scientific papers (individual and collaborative) from AIOTA members are welcome for presentation.
3. A generalized presentation should preferably be avoided.
4. Registration is mandatory for submission in all categories of presentations in the conference.
5. Oral papers/exhibits/mini-movies which do not confine to the standards will not be accepted.
6. Participants will be allowed to present only those research papers which are accepted and not any other paper at the last minute.
7. Total time allotted for each oral paper presentation is only 10 minutes and 6 minutes for e-Poster Presentation.
8. Paper presentation/e-Poster in-absentia will not be allowed. However, in circumstances beyond control, the Chairperson of the Scientific Program Committee can use her discretion and may grant permission to the co-author, to present the paper in the non-competitive category.
9. Scientific papers under the competitive category will be peer reviewed by two experts in the specified field prior to the conference.
10. Abstracts can be submitted in both Competitive and Non-Competitive categories.
11. Presenters should contact the scientific committee to display/upload their presentation for oral/e-Poster on the first day of the conference at 8.30 am.
12. e-poster presentation is non-competitive.
13. The decision of the Scientific Chairperson shall be final regarding the allocation of presentation categories (Oral Competitive, Oral Non-Competitive, or e-Poster). The Chairperson reserves the right to reassign submissions to a different category if deemed necessary. Additionally, oral presentations may be reassigned across interdisciplinary themes (e.g., Pediatrics to Neuroscience or vice versa) based on the number of submissions received for a particular category. The same will be informed to the participants before final acceptance of the scientific paper.
14. The design of the scientific program shall be final and binding in respect to acceptance of Abstracts/ Full Papers/ e-Poster/ Innovation Technology/ Mini Movies and also regarding allotment of time and duration of presentation.

1. SCIENTIFIC PAPER PRESENTATION

Instruction for Submission of Research Abstracts:

1. Abstracts of oral papers/exhibits should be submitted to email id scientificchairperson.oticon26@gmail.com.
2. Members interested in participating in more than one category should submit an abstract for each category.
3. Members will not be allowed to participate in categories for which abstracts have not been submitted.
4. Authors should submit a structured abstract with headings:
 - a. Title
 - b. Authors (Full Name) along with details of Institution(s), City, State and Country
 - c. Background, Objectives and Study Design
 - d. Methods
 - e. Results
 - f. Conclusion
 - g. Trial Registration, if any
 - h. Funding
 - i. Acknowledgements
 - j. References (not more than 2 latest citations)
 - k. Keywords (3 to 5)

The abstract structure should not exceed 350 words.
5. The content of the abstract should be accurate, brief, clear, organized, self- contained, and in American (US) English language.
6. Abstracts may be submitted in both Competitive and Non-Competitive categories. It should follow the IJOT guidelines.
7. The equator conference abstract checklist and sample abstract are available at:

Instruction for Submission of Scientific Paper:

- 1. Scientific papers are invited, which describes and emphasizes the development in areas of education/academics, clinical practice, and policy decision making in occupational therapy.**
- 2. Registration for the conference is mandatory for presentation.**
- 3. The research work to be presented should be novel with sound scientific reasoning and pertaining to occupational therapy.**
- 4. Preparation of the scientific paper should be based on “Guidelines to Authors for Submission” that can be obtained from IJOT website: www.ijotonweb.org/contributors.aspx.**
- 5. All papers should include self-checked plagiarism report from authentic Plagiarism Check Software such as: iThenticate a product of Turnitin (<https://www.ithenticate.com/solutions/publications>) or any other reliable & authenticate software available with the authors’ institution.**
- 6. Scientific papers have to be submitted on acceptance of abstract to scientificchairperson.oticon26@gmail.com.**
- 7. Total time allotted for each oral paper presentation is only 10 minutes.**

2. e-POSTER PRESENTATION

Submission Guidelines for Abstracts:

1. Abstracts of e-Poster should be submitted to email id scientificchairperson.oticon26@gmail.com.
2. The content of the abstract should be accurate, brief, clear, organized, self-contained and in American (US) English language.
3. Abstracts of e-Poster may be presented in both Competitive and Non-Competitive categories.

Preparation of Power Point Presentation for Oral Scientific Paper presentation/ e-Poster:

1. Set the slide size of the page to “On-screen show” and landscape orientation in the page set-up section (Portrait orientation will not be displayed properly). Use standard slide size (4:3). Presentations should be in Microsoft Office Power Point version 2010-2013 in .ppt or .pptx format only or higher version.
2. Use high-contrast but minimal colors for lettering (font vs background); do not place too much text on each slide. Prefer presenting data using infographics, tables, graphs, clinical pictures and short key messages.
3. Presentations can be text, figures, charts, tables, images, and artwork but an e-Poster should not include any audio, video or animation.
4. Do not use special fonts which are not part of the standard PowerPoint package as this will cause problems while uploading your file and will not display well during the presentation.
5. Total number of slides should not exceed 20 slides for oral scientific paper presentation and 6 slides for e-Poster presentation for the main content. The font style can be Times New Roman/Arial/Cambria with at least 1.5 line spacing. The font size for the title of e-Poster presentation should be 32 or 36 and the main text headings 28, sub-headings 24 or 20 and the footnotes/references of size 10 to 14 (if any).

3. INNOVATIVE TECHNOLOGY

General guidelines:

1. Abstracts are (individual and collaborative) invited from Life members of AIOTA relevant to Occupational Therapy process and practice.
2. Conference Registration is mandatory for submission of abstracts.
3. The Innovative Technology may be presented in both Competitive and Non-Competitive categories.
4. Electrical power supply points will not be provided by the organizers; Presenters may arrange for batteries if the innovative technology is based on electric supply or else prefer avoiding use of electricity or batteries.
5. The place for display of innovative technology will be informed to the presenter on the 1st day of the conference.
6. Video or actual working of the device or the equipment needs to be presented during the judging.
7. Innovative technology should be based on sound clinical and scientific reasoning.

Guidelines for abstract submission:

1. Abstract should be submitted to email id scientificchairperson.oticon26@gmail.com.
2. Authors should submit a structured abstract with the following headings:
 - a. Title
 - b. Authors (Full Name) along with details of affiliations.
 - c. Background & Rationale: A brief statement about the problem or research gap and the importance of the innovation in the OT context with clinical and scientific reasoning.
 - d. Objective(s): What does the project or innovation aim to achieve?
 - e. Methodology: A short description of the design/development process, technology used, stakeholders involved and how it was tested or implemented?
 - f. Results/Innovation: Key findings, improvements, user response or unique features of the product/technology.
 - g. Cost of Innovative Technology.
 - h. Conclusion: Implications for OT practice, benefits, it's effectiveness if any and potential for wider application or future development.
 - i. Keywords: 3–5 keywords.
3. The decision of the scientific committee is final with respect to acceptance of the Innovative Technology.

Format:

- 1. Word count:** The word limits for the abstract should be between 250-300 words.
- 2. Text Only:** The abstract should be submitted as plain text, without tables, figures or images.
- 3. Originality:** Ensure the abstract presents original work, not previously presented at other conferences.
- 4. Relevance:** Ensure your abstract aligns with the exhibits focus.
- 5. Clarity & conciseness:** Use clear & concise language, avoid jargon or overly technical terms.
- 6. Adhere to deadlines:** Submit your abstract by the specified deadline.



4. MINI MOVIES

General Guidelines:

1. **Abstract should be submitted to e-mail id: scientificchairperson.oticon26@gmail.com.**
2. **Mini Movies are (individual and collaborative) invited from Life Members of AIOTA.**
3. **The Mini Movie should promote, create awareness about the Vision of Occupational Therapy.**
4. **Conference Registration is mandatory for the submission of Mini Movies.**
5. **The Mini Movie may be presented in both competitive and non-competitive categories.**
6. **Mini Movies should not exceed a time limit of 4 minutes.**
7. **Maximum number of participants per movie should not exceed 4.**
8. **Mini Movie should be shared by Google Drive to email ID: scientificchairperson.oticon26@gmail.com.**
9. **Edited movies should be of good quality with high resolution and must be submitted either via pen drive or Google drive, in Mp4 format. The video should be playable on commonly available Windows software, ensuring there are no technical or logistical issues.**
10. **The decision of the scientific committee regarding the acceptance of Mini Movies will be final.**

Guideline for abstract submission:

1. **Title: Use a brief, concise & capitalized title within 150 characters.**
2. **Background & Concept: Provide a brief overview of the theme or issue addressed by the film and its relevance to Occupational Therapy, technology and society at large.**
3. **Storyline & Approach: Describe the approach used in creating the mini movie, Include a short summary of the narrative or documentary structure and filming style. Mention the perspective, characters, or setting, if applicable.**
4. **Purpose & Impact: State what the film aims to achieve — awareness, education, advocacy, innovation, emotional engagement, etc. Briefly mention the takeaway message of the mini movie.**
5. **Creative Techniques: Describe the visual style, format (documentary, dramatization, animation, etc.), duration, and any innovative audio-visual elements used. Avoid including graphs, tables, or images in the abstract.**
6. **Word count: The abstract should be within 250 words.**

5. BEST DELEGATE OF OTICON 2026 AWARD BY KERALA BRANCH OF AIOTA

Guidelines:

- 1. Conference Registration is mandatory for participation.**
- 2. Interested members to participate in the award for the best delegate of OTICON 2026 have to register with the scientific committee on or before 31st December 2025.**

STUDENTS' SUBMISSION GENERAL GUIDELINES

- 1. Student Members from AIOTA recognized OT colleges only, can participate in the competitive category.**
- 2. Students' sessions are exclusively for undergraduate students and participation by postgraduate students in any form will disqualify the team from the competitive category & the team may then continue to participate in non-competitive category.**
- 3. Only one entry from each OT College in Poster, Innovative Technology and Street Play category is permitted. Two entries are permitted from each OT College for the OMG Provo Award for Humorous Poster category.**
- 4. Registration for the Students' events is mandatory in respective competitive categories i.e., Poster, Street play, OMG Provo Award for Humorous Poster category and Innovative Technology.**
- 5. Faculty in charge from the respective college should send the list of participants in Students' event with the conference registration numbers of the students duly signed and stamped to email id: scientificchairperson.oticon26@gmail.com.**
- 6. The number of student participants for poster/street play/innovative technology in each category should not exceed 10. Only 2 participants from the team shall be allowed to present the Poster and the Innovative Device.**
- 7. The number of participants for OMG Provo poster should not exceed two.**
- 8. Each institute should nominate a staff coordinator for the student events. Nomination is to be done by the HOD of the institute.**
- 9. All communication with the institutes will be strictly via official mail id of the institute.**
- 10. WhatsApp communications will not be entertained.**

1. STUDENTS' POSTER

Guidelines:

- 1. The poster should be in portrait orientation with the size of 4 feet (height) x 3 feet (width).**
- 2. The poster should be 2 dimensional on a plain chart/card paper, Pop-ups or any hangings from the poster will not be allowed.**
- 3. Three dimensional Posters will be disqualified.**
- 4. Participants are encouraged to present evidence-based information to showcase the poster theme.**
- 5. In case of any violation of rules, the team shall be disqualified from the competition. However, the team may be allowed to present the poster under the non-competitive category.**
- 6. The poster should be self-made by use of manual drawings, paintings or photographs. Copyrighted materials (digitally designed pictures, drawings, paintings, photographs etc.) from the internet will not be allowed.**

2. STUDENTS' STREET PLAY

Guidelines:

- 1. Street play should be composed, based on theme of “Digital Detox: The Therapy of Tomorrow - Encouraging Real-Life Occupations in a world lost to screens”.**
- 2. The street play should be in English or Hindi.**
- 3. Use of local slang and common expressions are allowed.**
- 4. The use of placards is allowed.**
- 5. No props allowed.**
- 6. Street play should be composed, based on current evidence-based knowledge, gelled with creativity and extravaganza. The time limit for each street play is 10 minutes.**
- 7. In case of any violation of rules, the team shall be disqualified from the competition (like: The use of Vulgarity in words or action, objectionable portrayal of any person, place or incidence, use of props, extending beyond the time frame). The decision of the chairperson, scientific program committee will be final.**

3. STUDENTS' INNOVATIVE TECHNOLOGY

Guidelines:

- 1. Electrical power supply points will not be provided by the organizers; Presenters may arrange for batteries if the innovative technology is based on electric supply or else prefer avoiding use of electricity or batteries.**
- 2. Presenters should contact the scientific committee for their requirements of table/space etc. for display of innovative technology on the 1st day of conference at 8.30am.**
- 3. Video or actual working of the device or the equipment needs to be presented during the judging. Innovative technology should be based on sound clinical and scientific reasoning.**

4. STUDENTS' OMG PROVO HUMOROUS POSTER

Guidelines:

- 1. The poster should depict the latest and/or novel information related to Occupational Therapy in an original and creative artwork in a humorous concept.**
- 2. The humor depicted should not hurt/harm the sentiments of the professionals and the profession directly.**
- 3. Copyrighted materials (pictures, drawings, paintings, photographs etc.) from the internet will not be allowed.**
- 4. The size of the poster should be A3 with portrait orientation.**
- 5. The poster should be 2 dimensional on a plain paper.**
- 6. Pop-ups or any hangings from the poster are not allowed.**
- 7. Three dimensional Posters will be disqualified.**
- 8. The poster can be handmade or digital.**
- 9. In case of any violation of rules, the team shall be disqualified from the competition. However, the team may be allowed to present the poster under the non-competitive category.**

5. BEST STUDENT DELEGATE OF OTICON 2026 AWARD BY KARNATAKA BRANCH OF AIOTA

Guidelines:

- 1. Conference Registration is mandatory for participation.**
