### 4. Eligibility Criteria

- 4.1. The nominee shall be a current MDA Member of the year of nomination.
- 4.2. The nominator shall be the dietetic intern of the university where the CI are currently working.
- 4.3. Each institution of higher learning can nominate ONE (1) candidate through the respective programme head/ programme coordinator with the following supporting documents:
  - Clinical Instructor Award Nomination Form
  - At least three (3) written evidence from the dietetic interns outlines specific examples of how the nominee meets or exceeds the selection criteria.
  - Evaluation from Lecturer/Peer
- 4.4. The ASG committee would invite the nominee to submit the application package, including an electronic portfolio (See e-portfolio), starting <u>15<sup>th</sup> May 2024</u>.
- 4.5. Nominees must submit an e-portfolio of their supporting materials to the MDA Award Committee by 31st May 2024 for the evaluation process

#### 4. E-Portfolio

The e-portfolio (electronic portfolio) is an electronic collection of evidence that shows your journey in the dietetics profession over time. The e-portfolio should encompass material relevant to the "Merit Criteria" (see below) and include evidence of achievement, photos, and/or videos. It should highlight the most impactful project/activities relevant to the award.

To facilitate the review process, the material must be presented in electronic form, in the following order and include:

Brief Highlights: a brief one-para highlight of no more than 250 words provides
a clear and thematic picture describing the nominee's accomplishment. The
abstract may be used for website / Facebook in highlighting the award
recipients.

#### Curriculum Vitae –

- o A comprehensive document lists the qualifications and achievements. The CV is more detailed than a resume, but for this award submission, the CV should not be more than 5 pages.
- o Include personal details, academic history, professional achievement, and current roles and teaching responsibilities, especially clinical teaching.
- o Besides, the contributions to the MDA and other achievements (e.g in media or involvement in University activities, recognition/ awards) should also be included in the CV.

#### • Evidence for the Merit Criteria -

o This section should demonstrate the role as a CI and provide evidence for the following "Merit Criteria". The materials relevant to the "Merit Criteria" such as evidence of achievement, photos, and/or videos can be included. The most impactful project/ activities relevant to the award must be highlighted.

#### 5. Merit Criteria

As the intent of the award is to honour outstanding CI for their contribution in teaching, leadership and mentoring of dietetic interns, nominees will be judged on the basis of the following **merit criteria**:

- 5.1. Consistently demonstrates excellence as a preceptor by creating an environment of learning that has resulted in meaningful learning experiences
- 5.2. Acts as a role model by demonstrating outstanding competence and professionalism in the practice setting that meets dietetic standards of practice
- 5.3. Actively and consistently demonstrates strong leadership, knowledge and a professional approach during interactions with the dietetic interns and colleagues.
- 5.4. Demonstrates an ongoing willingness to precept students and facilitate learning using a creative, collaborative approach, setting evidence-based goals to meet objectives, monitoring progress and providing constructive on going evaluation to achieve student success
- 5.5. Demonstrates a commitment to the relationship by recognizing the unique needs of each student and dedicates the necessary time to support and enhances the student learning experience.


