In the event of such termination, the sponsor waives any and all damages and claims for damages and agrees that the sole liability of SELSMA shall be to return to each sponsor any rental payments received.

7. LIABILITY

In no event shall SELSMA be liable to the Sponsor for any direct, indirect, incidental, special, consequential or punitive damages, or any damages whatsoever, resulting from the execution or non-execution of this agreement.
