<u>Services offered by MATEXIL (Formerly SRTEPC) to its Members in promoting</u> <u>Exports of Man-Made Fibre Textiles and Technical Textiles</u>

MATEXIL (Formerly SRTEPC) continues to promote exports of Manmade Fibre (MMF) Textiles such as Fibre, Yarns, Fabrics and Made ups (including Home Textiles) since its formation in 1954 by engaging with its members and providing services and support to them.

In 2022, the Government has assigned the role of export promotion of Technical Textiles to our Council in addition to MMF Textiles.

The Council has over 4,000 companies who are exporters of MMF Textiles including Technical Textiles as its members.

The Council helps its members in promoting exports.

The Services offered by the Council are as follows:

1. Marketing Support

- **Provide Assistance to find Export Markets:** MATEXIL provides its members details on Export Trends Global & India, Analysis of Global Markets, Analysis of Growing Markets, etc. The Council assist its members to find new Export Markets.
- Participation in Leading Global Trade Shows: MATEXIL facilitates exporters to participate in global exhibitions and BSMs in leading markets as well as in emerging markets for MMF Textiles and Technical Textiles.
- Connecting with Reliable Buyers Across the Globe: MATEXIL connects
 exporters with leading buyers and facilitate meetings to promote exports. The
 Council provides list of Foreign Buyers to its Members.
- Sponsoring Delegations to Leading Global Markets: MATEXIL organizes visits of trade delegations consisting of its Members to leading markets from time to time.
- Organizing Reverse Buyer-Seller Meets: MATEXIL organizes RBSM (Reverse Buyer Seller Meets) in India to facilitate B2B meetings between exporters and Foreign Buyers.

- Publicize on India's Capability to Supply MMF Textiles & Technical Textiles: MATEXIL takes steps to enhance the image of India as a reliable supplier of MMF Textiles and Technical Textiles.
- Organize MMF Textiles Seminars & Workshops: MATEXIL organizes Seminars, Workshops, Conferences, etc. on various subjects related to Exports of Man-Made Fibre Textiles and Technical Textiles.

2. Liaising with Government and Other Bodies

- Support in Resolving Exports Issues: MATEXIL takes up issues faced by its Members with Government Bodies like Customs, GST Commissionerate, RBI Bank, ECGC Ltd, Regional offices of DGFT and Textiles Commissioner etc.
- Liaising with Government Authorities: MATEXIL seeks inputs, suggestions on various policy matters including on Export Benefits, Indirect Taxations, Foreign Trade Policy, Customs Law, GST Laws and represents them to the Government.

3. Advisory Role

 Assistance & Guidance on Exports Benefits: MATEXIL provides assistance and guidance on export benefits like RoDTEP, RoSCTL, Duty Drawback, Brand Rate of Duty Drawbacks, GST Refunds , HS Codes etc. The Council also provides guidance on Schemes such as PLI, PM Mitra Scheme etc to its members.
