## 2 General Terms & Conditions

### 2.1 Award

Each award winner will be given a trophy and a certificate

### 2.2 Eligibility Criteria

- a) Minimum exports to qualify for all the Segment is Rs. 10 crores for the last Financial Year.
- b) Awards will be granted for the financial year 2023-24 (April-March)
- c) Application for awards will be considered subject to the condition that nothing adverse about the business dealings of the applicant has come to the notice of the Council and/or the Authorities.
- d) Members can apply for awards in various categories and will be eligible for more than one award. There is no restriction on number of awards a member can receive.
- e) Application for awards has to be submitted in the proforma prescribed by the Council, duly certified by the Chartered Accountant.
- f) Separate Applications Should Be Submitted For Awards In Different Categories.**
- g) Selection for awards will be made by the Sub-Committee appointed by the Committee of Administration of the Council. The decision of the Council will be final and cannot be contested. The Council reserves the right to re-verify the export figures submitted by the applicant.
- h) Export performance includes only those exports which have been effected in the name of the applicant.
- i) Export performance will be computed on the basis of FOB (excluding insurance, freight and commission) price in Indian rupees.
- j) H.S. Codes of the products should also be mentioned to ascertain whether the products fall under the purview of the Council.
- k) The total value of exports of all the items that fall under the purview of the Council will be considered for MATEXIL Special Award and to qualify the applicant should have a minimum export performance of Rs. 75 crores for the relevant financial year 2023-2024.

- l) Nominations are invited from the company who has produced specially processed/innovative products in any categories of technical textiles. They should send a write-up on their company's letterhead of not more than 100 words to the Council, informing on technology adopted for manufacturing the product along with sample of the products.
