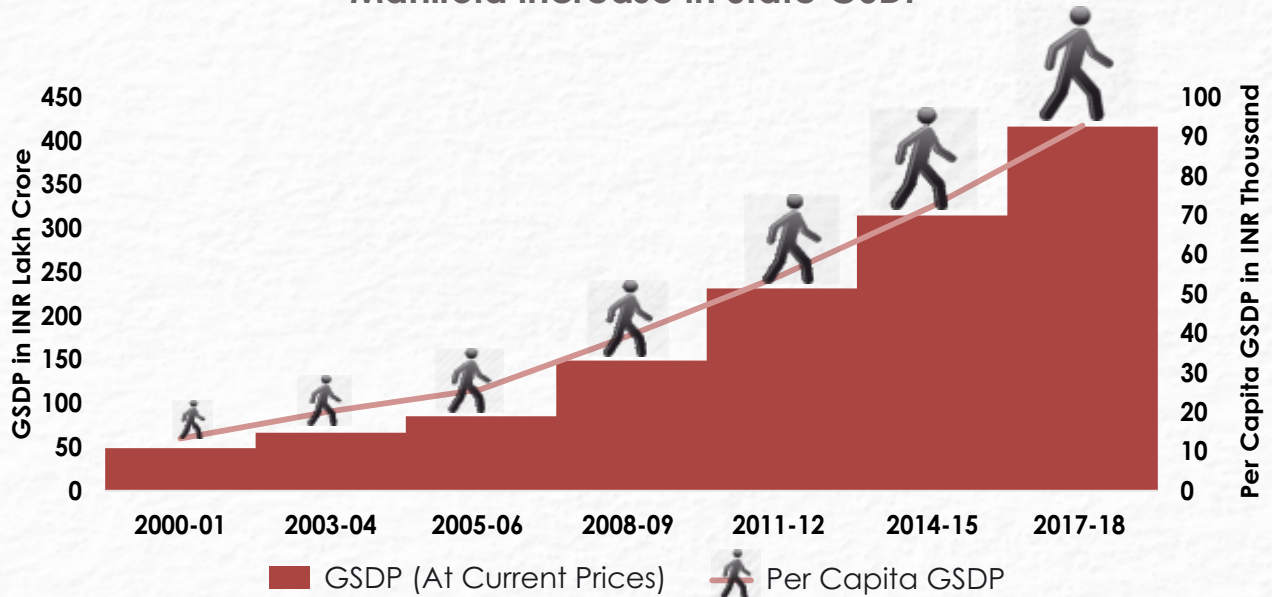

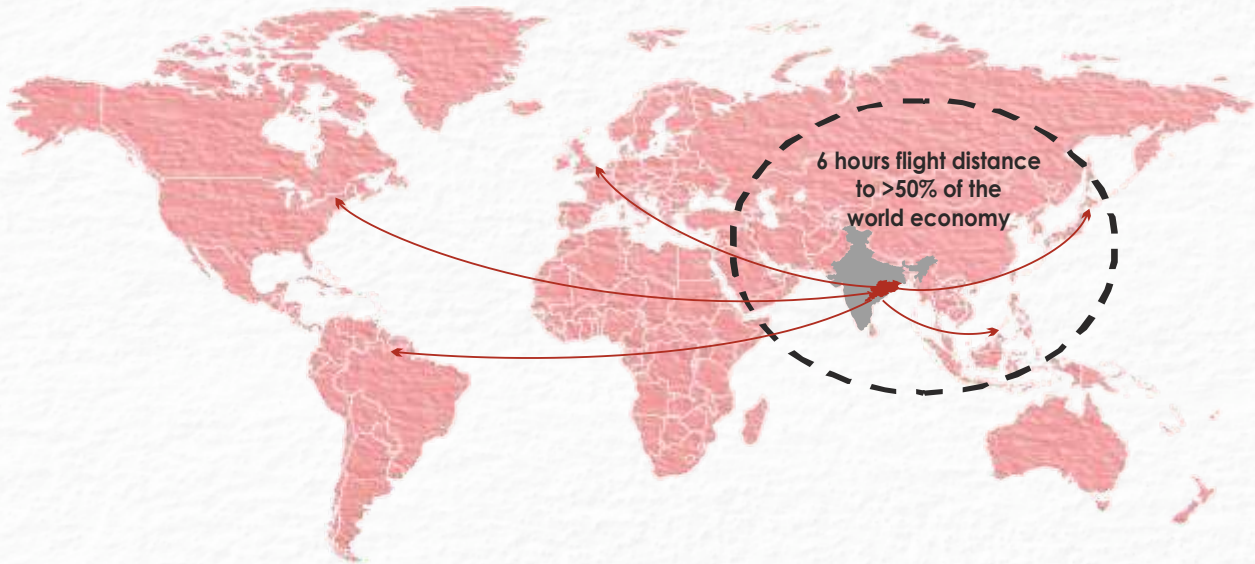

- ◆ **Paradip Port** - 1st in Average Output Per Ship Berthday and 2nd in capacity & quantity of Traffic Handled in India

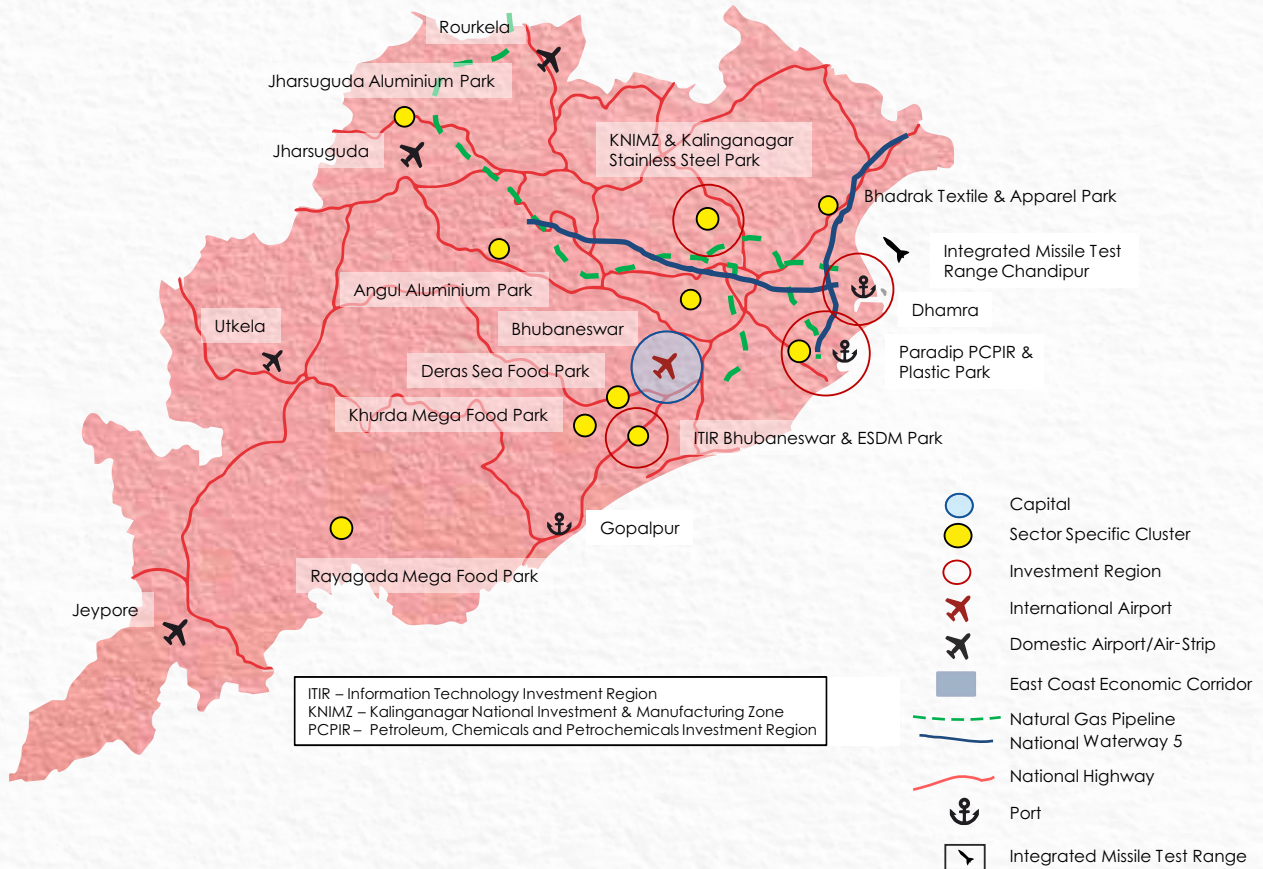
